To: Persons Interested in the Proposed Construction of a 161-kV High Voltage Transmission Line and new substation in Wabasha County, Minnesota to Relocate 10.4 miles of Existing 161-kV Transmission Line Currently Located Near the Cities of Plainview and Kellogg in Wabasha County, Minnesota; the Minnesota Public Utilities Commission Energy Facilities General List; Local Officials; Tribes; and Property Owners

**Re: Notice of Filing of Joint Certificate of Need and Route Permit Application with the Minnesota Public Utilities Commission
MPUC Docket Nos. ET3/CN-23-504 and ET3/TL-23-388**

Dairyland Power Cooperative (Dairyland) is proposing to relocate approximately 10.4 miles of an existing 161-kilovolt (kV) high voltage transmission line between the Wabaco Substation and Mississippi River. The project will include construction of approximately 13.3 miles of 161-kV transmission on a new right-of-way and construction of a new 161/69-kV substation and associated facilities to be located near the City of Kellogg in Wabasha County, Minnesota (the Wabasha Relocation Project, or the Project). No construction is contemplated across the Mississippi River as a part of this Project.

Dairyland submitted an application to the Minnesota Public Utilities Commission (Commission) for a Joint Certificate of Need and Route Permit (Application) for the Project (MPUC Docket Nos. ET3/CN-23-504 and ET3/TL-23-388) pursuant to Minn. Stat. § 216B.243 and Minn. R. 7849 (Certificate of Need) and the alternative permitting process contained in Minn. Stat. § 216E.04 and Minn. R. parts 7850.2800 to 7850.3900 (Route Permit).

PROJECT DESCRIPTION

The Project is a relocation of approximately 10.4 miles of Dairyland's existing LQ34 line, which presently connects to the Wabaco Substation (located approximately 2 miles south of the Town of Plainview) and to the Alma Substation (located on the east side of the Mississippi River in Wisconsin). The Project starts in Plainview Township, northeast of the Town of Plainview, and traverses northeast through Highland, Watopa, and Greenfield Townships, and ends at a new 161/69-kV substation east of the City of Kellogg in Wabasha County, Minnesota near the Mississippi River.

The accompanying map outlines the location of the Project.

ROUTE PERMIT PROCESS

A Route Permit from the Commission is required before the Project can be constructed. The Power Plant Siting Act (Minn. Stat. Ch. 216E) and Minn. R. parts 7850.1000 to 7850.5600 establish the requirements for submitting and processing a Route Permit application. The statutes and rules also establish notice requirements for various stages of the process. The Route Permit application will be considered by the Commission under the alternative permitting process in Minn. Stat. § 216E.04 and Minn. R. parts 7850.2800 to 7850.3900. The Commission has up to six months from the time the application is accepted as complete to process and make a decision on the Route Permit according to Minn. Stat. § 216E.04, subd. 7, and Minn. R. 7850.3900, subp. 1. The Commission may extend this time limit for up to three months for just cause or upon agreement of the applicant.

Within 60 days after the Commission accepts the application as complete, the Commission and the Department of Commerce, Energy Environmental Review and Analysis (EERA) unit will hold a public information and scoping meeting to provide information and seek comments from the public. At this meeting, members of the public may propose additional route alternatives for consideration in the environmental assessment that the EERA will prepare. Once the public meeting is scheduled, notice of the meeting will be provided to persons whose names are on the Project contact list and will be published in a legal newspaper of general circulation in the Project area. After the environmental assessment has been completed, a public hearing will be held on the application. Any person may speak at the public hearing, present documentary evidence, ask questions of Dairyland's representatives and EERA staff and submit comments.

If the Commission issues a Route Permit for the Project, Dairyland may, if necessary, exercise the power of eminent domain to acquire land necessary for the Project (Minn. Stat. § 216E.12; Minn. Stat. Ch. 117).

CERTIFICATE OF NEED

A Certificate of Need from the Commission is required before the Project can be constructed. Minn. Stat. § 216B.243, and Minn. R. Ch. 7829 and 7849 establish the requirements for submitting and processing a Certificate of Need application. The statutes and rules also establish notice requirements for various stages of the process. The Certificate of Need application will be considered by the Commission under Minn. Stat. § 216B.243 and the exemptions granted under Minn. R. Ch. 7849. The Commission has up to 12 months from submission of the application to make a decision on the Certificate of Need.

Dairyland has filed a Joint Certificate of Need and Route Permit Application with the Commission.



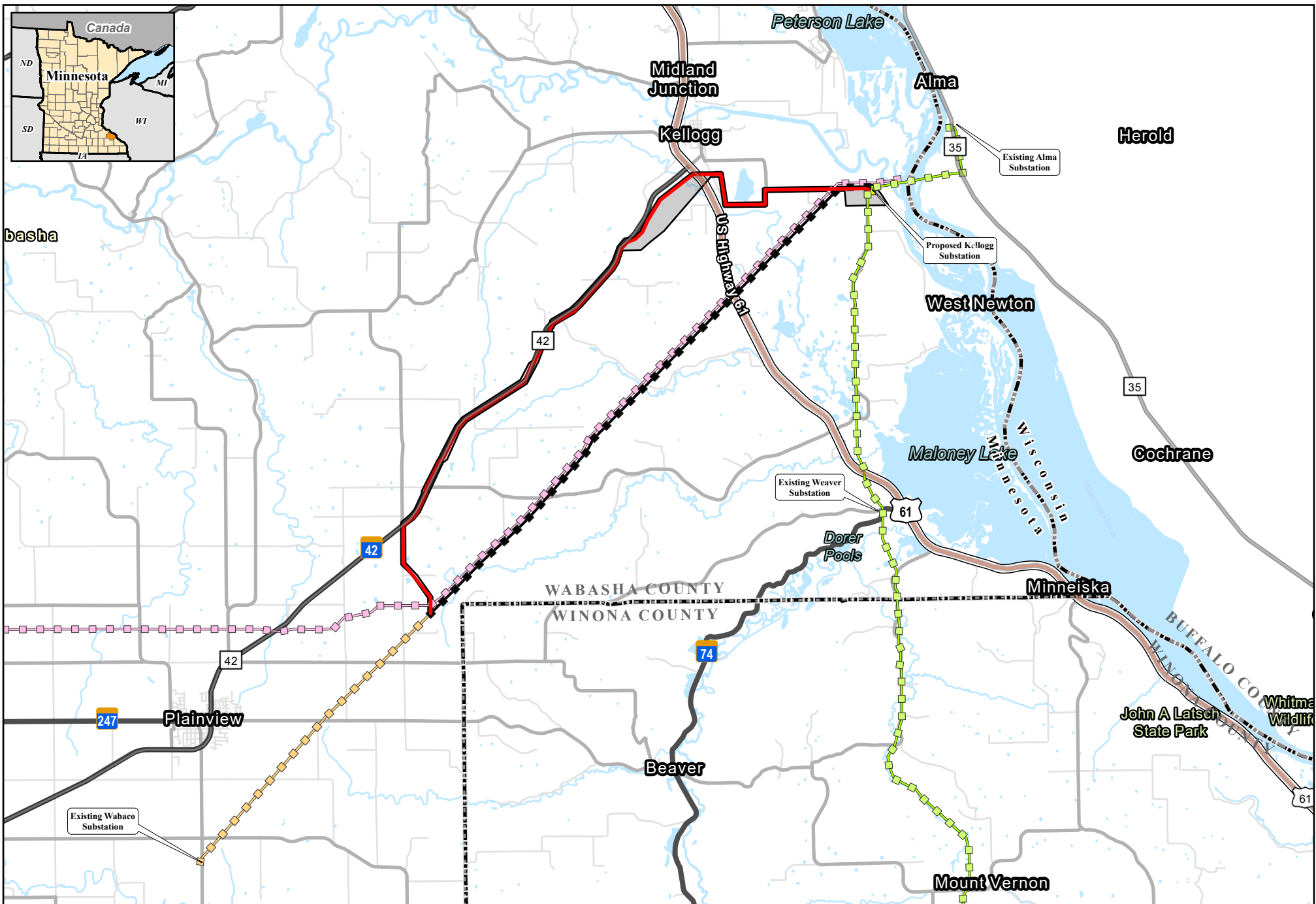
