VI. Description and Purpose of Filing

A. Reasons for the Filing

The purpose of this filing is to request approval of an agreement to transfer service rights for two small tracts of land in Big Lake Township, Sherburne County, Minnesota, that are currently located in the assigned service territory of Connexus Energy to Xcel Energy.

This proposed service territory transfer was prompted by a request made by a long-standing member-owner of Connexus Energy who owns all of the undeveloped land subject to the proposed service territory transfer. The member-owner has partnered with Sunrise Energy Ventures, LLC to construct a community solar garden on land owned in part by the member-owner and in part by Sunrise Energy with the intent to apply for participation in Xcel Energy's Solar*Rewards Community® program.

The vast majority of the land upon which the proposed community solar garden is to be constructed is located in Xcel Energy's service territory. However, the two small tracts of land that are subject to the instant Petition are located in Connexus Energy's service territory, as reflected on the Commission's digital service maps. Although it is anticipated that the proposed solar garden will qualify as a solar generation facility pursuant to Minn. Stat. § 216B.1641, both Minnesota law and Xcel Energy's solar garden tariff require that a solar garden be located entirely within Xcel Energy's service territory in order to participate in Xcel Energy's Solar*Rewards Community® program. As a result, the

proposed solar garden cannot be built at the designated location unless service territory rights for the tracts of land at issue are transferred to Xcel Energy.

This proposed service territory transfer will also result in a straightening of the boundary line between the service territories of the two utilities, which currently runs over the subject land at a slight angle. Following the proposed transfer, the new boundary line will run north-south down the middle of the nearest half-section line.

B. Affected Customers and Existing Facilities

The Commission's approval of this Agreement will result in the transfer of service territory rights for two small tracts of land located in Sherburne County from Connexus Energy to Xcel Energy. The subject land is currently undeveloped with no existing electrical services. The subject land is owned by a single member-owner of Connexus Energy who has requested this transfer of service territory.

**SERVICE TERRITORY TRANSFER AGREEMENT
BETWEEN
CONNEXUS ENERGY
AND
NORTHERN STATES POWER COMPANY,
D/B/A XCEL ENERGY**

This agreement entered into this 2nd day of November, 2017 (“Agreement”) between CONNEXUS ENERGY, a Minnesota electric cooperative with its principal office located at 14601 Ramsey Boulevard, Ramsey, Minnesota and NORTHERN STATES POWER COMPANY, a Minnesota corporation and public utility doing business as Xcel Energy, with its principal office located at 414 Nicollet Mall, Minneapolis, Minnesota (individually, a “Party,” and collectively, the “Parties”).

RECITALS

A. Connexus Energy, a Minnesota cooperative corporation owns and operates an electric distribution system as a cooperative association formed pursuant to the provisions of Minnesota Statutes Chapter 308A.

B. Northern States Power Company, a Minnesota corporation doing business as Xcel Energy (“Xcel Energy”), is a public utility under Minnesota Statutes § 216B.02, subd. 4.

C. Pursuant to the electric service area assignments of the Minnesota Public Utilities Commission (“Commission”) and Minnesota Statutes §§ 216B.39 and 216B.40, Connexus Energy and Xcel Energy have exclusive rights to provide electric service to customers within their respective service territories.

D. In response to a request made by a customer with electric services in both Parties’ respective service territories, the Parties agree, subject to Commission approval, to transfer two tracts of land located in Connexus Energy’s service territory in Sherburne County, Minnesota, to Xcel Energy’s service territory.

NOW, THEREFORE, in consideration of the promises exchanged herein, the Parties agree as follows:

1. Scope of Agreement:

Connexus Energy will transfer to Xcel Energy the service territory rights for two tracts of land in Big Lake Township, Sherburne County, Minnesota, which do not have designated street addresses, but which are located in Section 23 of Township 33N, Range 28W, and which are designated as a tract of Sherburne County Parcel ID 10-323-2401 and a tract of Sherburne County Parcel ID 10-323-3101.

The legal description for Parcel ID 10-323-2401 is as follows: That part of the Southeast Quarter of the Northwest Quarter of Section 23, Township 33 North, Range 28 West, Sherburne County, Minnesota, lying southerly of the Burlington Northern Santa Fe Railroad. Within Parcel ID 10-323-2401, the tract of land to be transferred from Connexus Energy to Xcel Energy is described as follows: The east 300 feet of the Southeast Quarter of the Northwest Quarter of Section 23, Township 33 North, Range 28 West, Sherburne County, Minnesota, lying southerly of the Burlington Northern Santa Fe Railroad, as reflected in **Attachments 1-3**.

The legal description for Parcel ID 10-323-3101 is as follows: The East Half of the Southwest Quarter of Section 23, Township 33 North, Range 28 West, Sherburne County, Minnesota. Within Parcel ID 10-323-3101, the tract of land to be transferred from Connexus Energy to Xcel Energy is described as follows: The east 300 feet of the East Half of the Southwest Quarter of Section 23, Township 33 North, Range 28 West, Sherburne County, Minnesota, as reflected in **Attachments 1-3**.

2. Transfer of Existing Facilities and Customers:

No existing customer of either Party has electric services that will be affected by this transfer. However, this transfer is made at the request of the customer that owns the tracts of land that are subject to the transfer.

3. Compensation:

The Parties agree that due to the unique circumstances set forth in Sections 2 and 5 herein, no compensation is due from Xcel Energy to Connexus Energy for this transfer of service territory.

4. Reservation of Rights:

Except as specifically set forth herein, this Agreement does not modify or limit the legal rights of either Party.

5. No Precedent:

The Parties recognize that this Agreement is the result of negotiations between the Parties, as well as unique circumstances arising from the present diagonal nature of the boundary line between the service territories of the Parties as it affects the tracts of land subject to this transfer, in that the present boundary line prevents the customer from pursuing an application to participate in Xcel Energy's Solar*Rewards Community® program. The Parties recognize and agree that neither this Agreement nor the Commission's approval of this Agreement shall have any binding effect or legal precedent on either Party in any other matter now or in the future.

6. Request for Commission Approval of the Agreement:

Upon execution of this Agreement by the Parties, Connexus Energy will prepare a Joint Petition to the Commission by the Parties to approve the transfer of service territory rights for the documented tracts of land, along with this Agreement. Upon receiving a draft of such Joint Petition, Xcel Energy shall retain the right to review the Joint Petition prior to signature of said document by any duly authorized representatives. Upon the signature of the Joint Petition by the duly authorized representatives of the Parties, Connexus Energy will file the Joint Petition to the Commission along with this Agreement.

7. Miscellaneous:

- (a) Entire Agreement and Modification. This Agreement contains the entire agreement and understandings of the Parties hereto regarding the scope of the Agreement and appropriate compensation for the transfers of the exception areas that are the subject of this Agreement. All previous communications or agreements between the Parties hereto, either verbal or written, with reference to the subject matter of this Agreement are hereby abrogated. No amendment, modification or waiver of, or consent with respect to any provision of this Agreement shall be effective unless the same shall be in writing and signed by a duly appointed representative of all Parties, and then any such agreement, modification, waiver, or consent shall be effective only in the specific instance and for the specific purpose for which given.
- (b) Assignment. Neither Party shall assign or sublet this Agreement, whether voluntarily, involuntarily, or by operation of law, without the prior written consent of the other Party.
- (c) Severability. If any provision of this Agreement shall be found invalid or unenforceable, in whole or in part, by a court of competent jurisdiction or the Commission, then such provision shall be deemed to be modified or restricted to the extent and in a manner necessary to render the same valid and enforceable, or if that is not possible, such provision shall be stricken and deleted from this Agreement, as the case may require, and this Agreement shall then be construed and enforced to the maximum extent permitted by law and with the purpose to achieve the fundamental intent of the Parties.
- (d) Choice of Law. This Agreement shall be construed and interpreted in accordance with the laws of the State of Minnesota and excluding any choice of law or rules that may direct the application of laws of another jurisdiction.
- (e) Agreement Drafted Jointly. The Parties agree that neither of the Parties shall be deemed solely responsible for drafting all or any portion of this Agreement, and in the event of a dispute, responsibilities for any ambiguities arising from any provision of this Agreement shall be shared equally between the Parties.



- (a) Regulation. The Parties acknowledge that this Agreement is subject to the jurisdiction of the Commission.

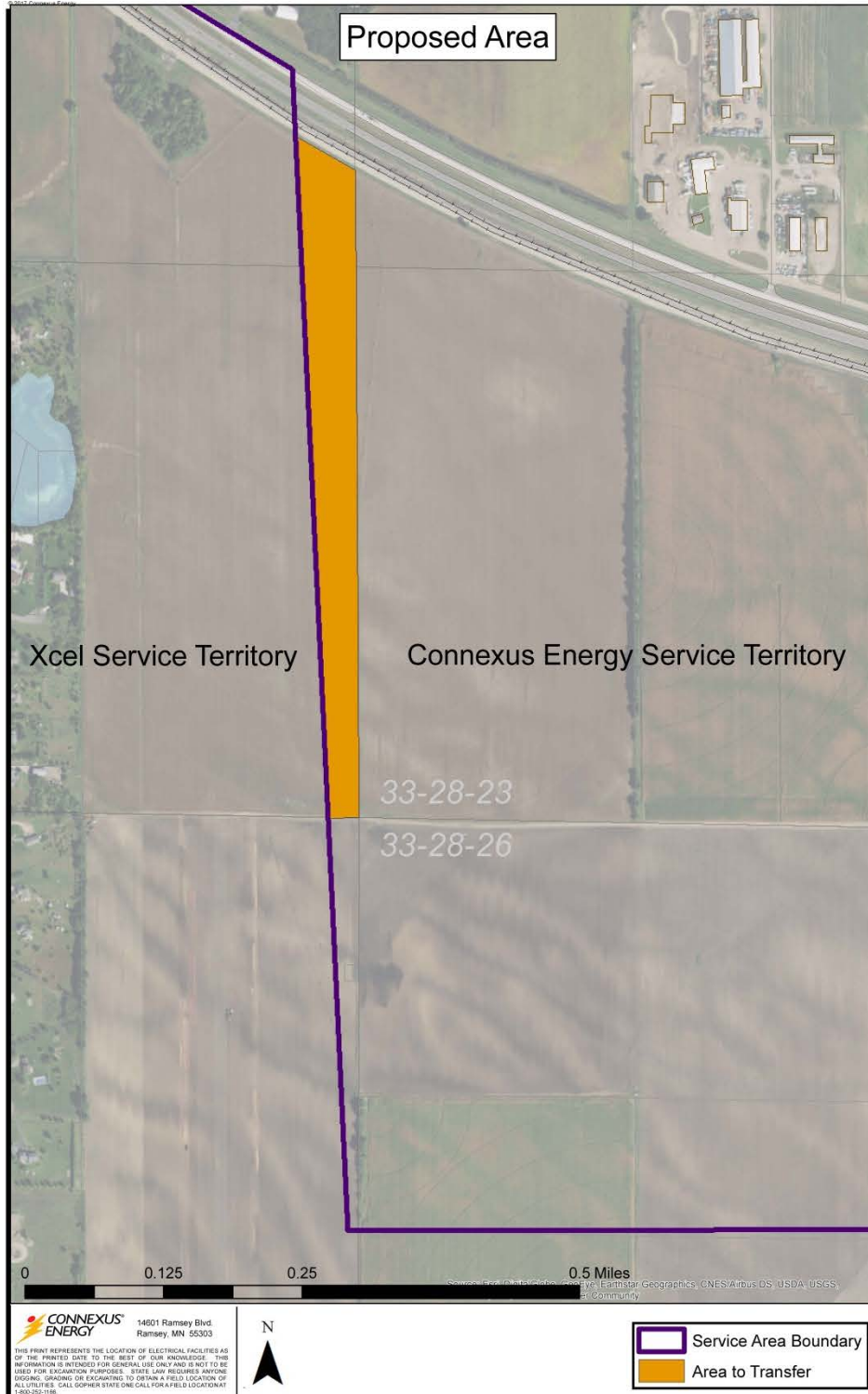

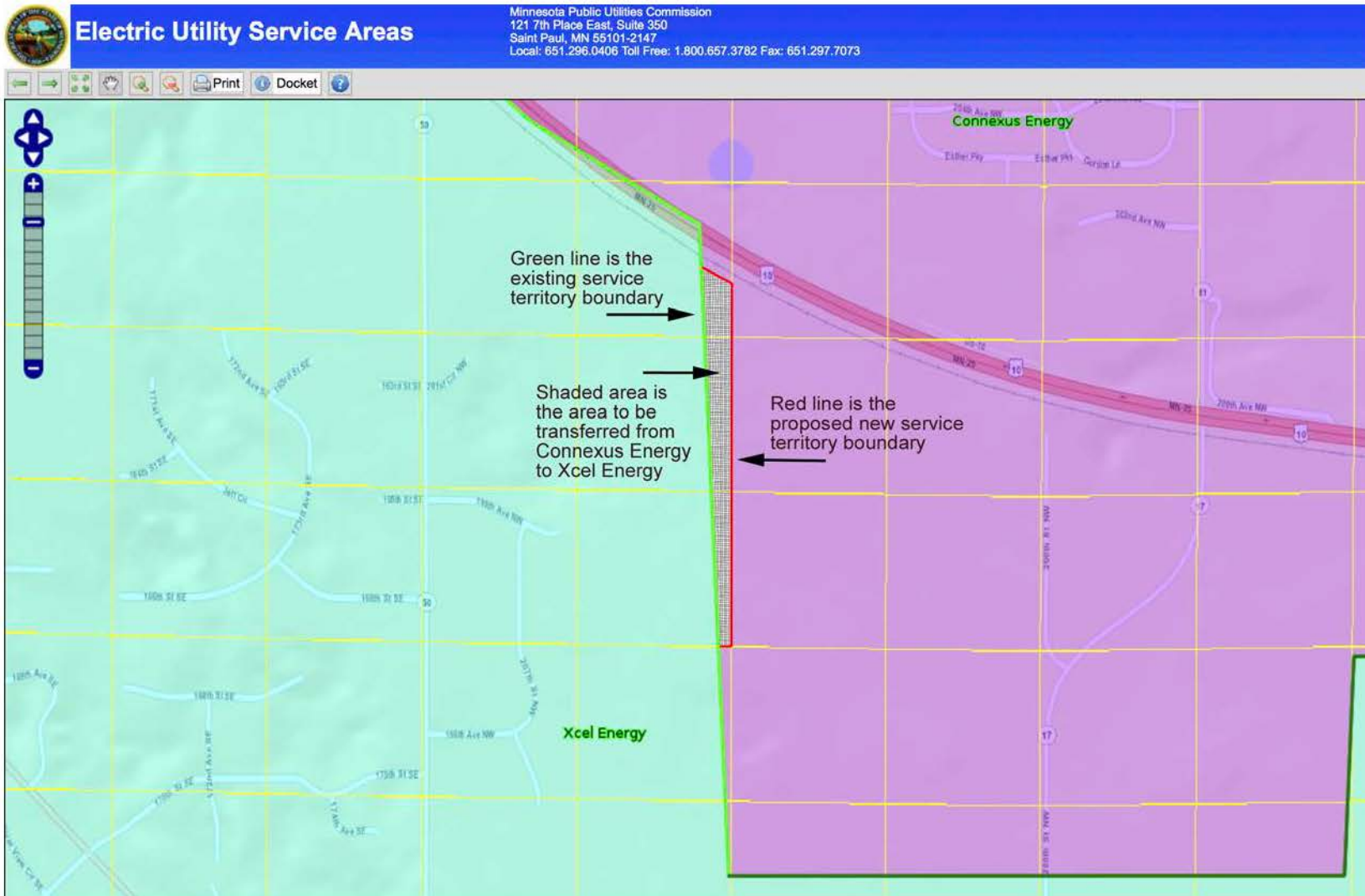

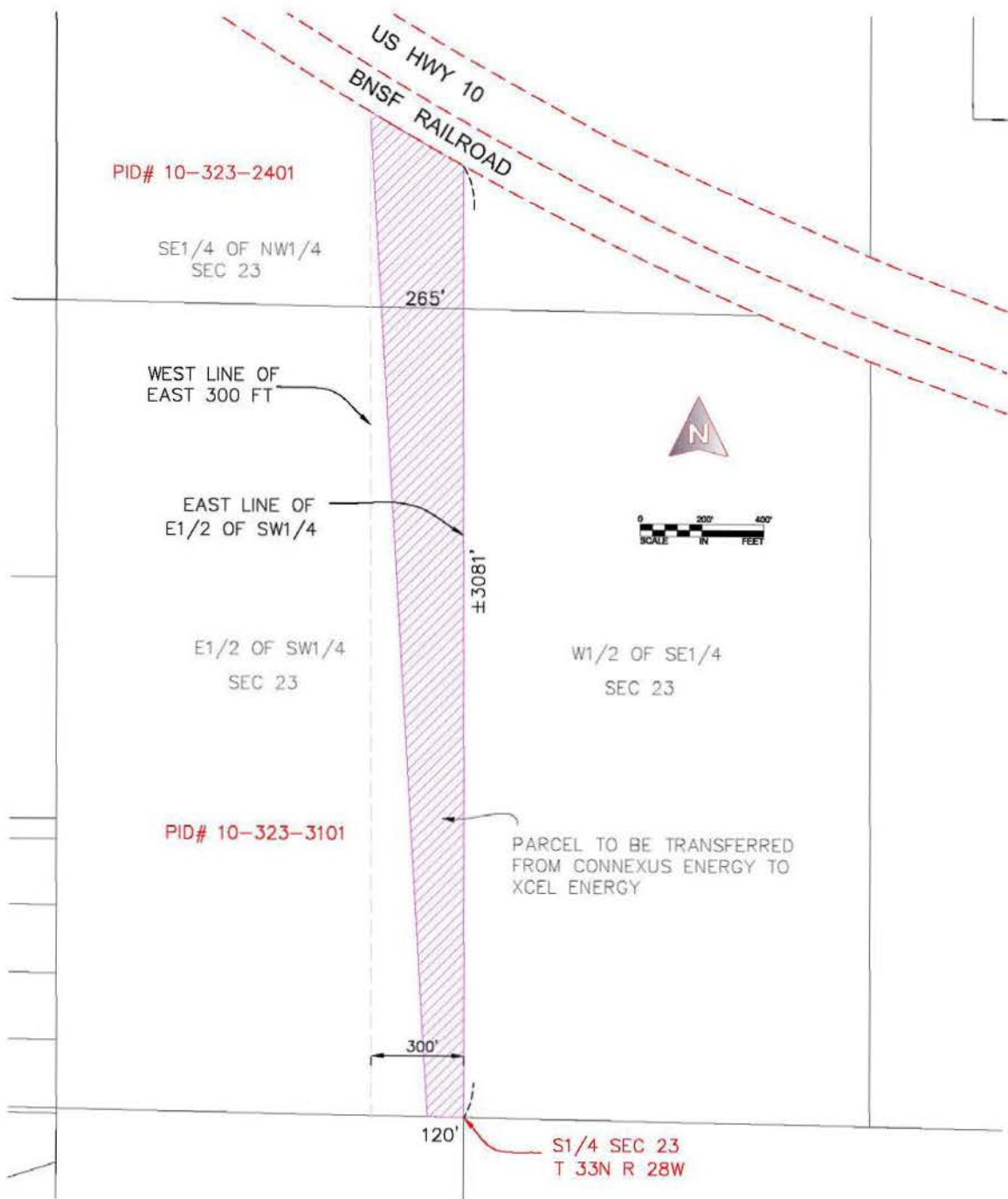
