Minnesota Power hereby submits via e-filing its combined Application for a Certificate of Need and a Route Permit for the Duluth Loop Reliability Project (the "Project"). The Project includes: (1) construction of approximately 14 miles of new 115 kV transmission line between the Ridgeview, Haines Road, and Hilltop Substations; (2) construction of a new approximately one-mile extension connecting an existing 230 kV transmission line to the Arrowhead Substation; (3) upgrades to the Ridgeview, Hilltop, Haines Road, and Arrowhead substations; and (4) reconfiguration, rebuild, and upgrade to existing transmission lines and communications infrastructure in the Project area. The Project is needed to replace the system support once provided by coal-fired baseload generators located along Minnesota's North Shore by addressing severe voltage stability concerns, relieving transmission line overloads, and enhancing the reliability of Duluth-area transmission sources.

Please note that Minnesota Power has designated Appendix R of the Application as NONPUBLIC because it contains sensitive cultural and environmental information. Public and nonpublic versions of Appendix R have been provided.

The initial application fee payment required under Minn. R. 7849.0210 is being sent to the Minnesota Public Utilities Commission under separate cover. The initial application fee payment required under Minn. R. 7850.1800 and additional copies of the Application are being sent to the Department of Commerce under separate cover. A

short summary of this Application is being distributed as required by Minn. R. 7829.2500, subp. 3.

### SUMMARY OF CERTIFICATE OF NEED FILING

Pursuant to Minn. Stat. § 216B.243, Minnesota Power has submitted an application for a certificate of need for the Duluth Loop Reliability Project (the "Project"). The Project includes construction of new high voltage transmission lines and necessary substation and transmission infrastructure upgrades, reconfigurations, and rebuilds in St. Louis County, Minnesota. Pursuant to Minn. R. 7829.2500, subp. 2, Minnesota Power provides this summary of its Certificate of Need filing.

The Project is needed to replace the system support once provided by coal-fired baseload generators located along Minnesota's North Shore by addressing severe voltage stability concerns, relieving transmission line overloads, and enhancing the reliability of Dulutharea transmission sources. The Project includes construction of a new 115 kV transmission line between the Ridgeview and Hilltop substations, construction of approximately a one-mile extension of an existing 230 kV transmission line, connecting to the Arrowhead Substation, and upgrades to the Ridgeview, Hilltop, Haines Road, and Arrowhead substations.
