Department of Commerce, Energy Environmental Review and Analysis (EERA) staff have completed the environmental assessment scoping process in the following matter:

In the Matter of the Joint Application of Minnesota Power for a Site and Route Permit for the 85-Megawatt Boswell Solar Project and Associated 2.45-mile 230-kilovolt Transmission Line in Itasca County, Minnesota

The scoping period for the environmental assessment (EA) was open from April 2, 2025, through May 5, 2025. Public meetings for the project were held on April 3 and 21, 2025. Oral and written comments were received from the public during the scoping period.<sup>1</sup> None of these comments suggested an alternative site for the Boswell Solar facility or an alternative route for the associated 230 kV transmission line. Accordingly, EERA staff recommends that the Commission authorize EERA to include solely the site and route for the project identified by Minnesota Power in its joint application in the scoping decision for the EA.

EERA staff is available to answer any questions the Commission may have.
