Global\*Tel Link Corporation d/b/a ViaPath Technologies ("GTL") and its affiliate Value-Added Communications, Inc. d/b/a ViaPath Technologies ("VAC") (GTL and VAC collectively, the "Company") respectfully submit the following information in compliance with the Order issued by the Minnesota Public Utilities Commission (the "Commission") on January 28, 2022 in the above-referenced docket. In the Order, the Commission approved the Company's use of the doing business as ("DBA") name "ViaPath Technologies" in Minnesota going forward.

First, in response to Ordering Clause #3, the Company affirms that notice of the DBA name was provided to any customers that have a subscription to receive service or have funds deposited with the Company for the placement of calls. The Company offers inmate calling services to correctional facilities in Minnesota, which allow incarcerated individuals to initiate telephone calls to their friends and family outside of the correctional facility. The DBA is reflected on the Company's websites and the Company's interactive voice response system ("IVR"). Very few of the Company's customers receive regular monthly invoices (such as bail bondsmen, attorneys, etc.), and the DBA also is reflected on those invoices.

Second, in response to Ordering Clause #2, the Company encloses updated tariffs for GTL and VAC. Each page of the tariffs is included in this filing to reflect the addition of the DBA name in the header and in the text as marked, and the Company's updated address in the footer. For GTL, additional substantive edits have been made on the following pages of the tariff:
