Coneflower Energy, LLC (Coneflower Solar) appreciates the thorough analysis and recommendations contained in the Administrative Law Judge's (ALJ) Findings of Fact, Conclusions of Law, and Recommendations (ALJ Report) dated June 26, 2025, in the above-referenced matter. Overall, the ALJ Report presents a comprehensive, thoughtful, and detailed review of the record in this proceeding.

Coneflower Solar has no exceptions to the ALJ Report but notes one very minor correction. Finding No. 2 should state that Apex, not Coneflower Solar, was founded in 2009 and is headquartered in Charlottesville, Virginia. With this small change, Coneflower Solar respectfully requests the Commission adopt the ALJ Report in full and issue a site permit for the Project containing the conditions recommended in the ALJ Report.
