<sup>4</sup> <u>SWIFT greater than TAP</u> - TAP is reviewed and approved for payment and then posted to SWIFT. SWIFT records the expenditure after TAP approval. There could be a lag in the receipt of reports, the approving of reports, and the posting of payments.

## 3) LINES:

<sup>5</sup> <u>DPS greater than TAP</u> - DPS lines are fiscal year-end June. TAP lines are calendar year June. DPS fiscal year-end June contains 115,698 lines of TAP calendar year-end December 2016, lines. DPS also contains 23,780 lines that are local niche service and interexchange service (IXC)-long distance. Local niche and interexchange tele cos are not required to file TAP reports.

<sup>&</sup>lt;sup>1</sup> <u>SWIFT greater than TAP</u> - SWIFT records revenue deposits from DPS. The TAP form records what <u>was</u> reported to DPS. TAP revenues would lag in revenue to SWIFT.

<sup>&</sup>lt;sup>2</sup> <u>SWIFT greater than DPS</u> - DPS deposits revenues to SWIFT. SWIFT revenues show greater than DPS. This could be due to report receipt, report processing, and the claiming of reimbursement.

<sup>&</sup>lt;sup>3</sup> <u>DPS greater than TAP</u> - DPS revenue is fiscal year 2017. TAP revenue is calendar year 2017. It is noted DPS fiscal year end contains some TAP calendar year end 2016 annual revenues. DPS data also contains revenue that is local niche service and interexchange service (IXC)-long distance. Companies report revenue to DPS but do not report to TAP. TAP records what <u>was</u> reported to DPS. TAP revenue is recorded after a lag.
