REPLY COMMENTS

I. INTRODUCTION

On April 21, 2017 the Minnesota Public Utilities Commission (or “Commission”) issued a Notice of Comment Period on Distribution System Planning Efforts and Considerations in docket No. E999/CI-15-556 (or “Notice”). In the Notice the Commission outlines questions intended to seek information regarding utility distribution planning operations. These Reply Comments provide Minnesota Power’s response to Comments filed in response to the Notice.

II. RESPONSE TO COMMENTS FILED

The Commission’s interest and investigation into utility distribution planning has been a worthwhile and informative exercise. Grid planning is a flexible and fast paced endeavor that oftentimes does not lend itself to concrete long-term planning processes. The Company appreciates the feedback from various stakeholders and offers the following Reply Comments in response.

Department of Commerce

In its Initial Comments, the Department of Commerce (“Department”) did not recommend that the Commission implement formal/standardized distribution plans at this time. Minnesota Power agrees with the assertion that it would be challenging for the Commission to be flexible enough to provide meaningful input to short-term distribution planning. As the Company has stated in prior comments in the docket, a unique aspect of Distribution Planning is that smaller capital projects are sometimes accelerated, canceled, or deferred if variables change after approval. A detailed or lengthy approval process would not be advantageous for the distribution planning process. A high-level distribution planning concept that provides the Company flexibility may be feasible, depending upon the parameters and timeline for approval.

The Department also recommends in its Comments that any requests for specific distribution planning requirements be directed through the annual Distributed Generation (“DG”) docket. While Minnesota Power appreciates the attempt to streamline the distribution planning processes and dockets, the Company believes the DG docket an ill-fitting recommendation for this particular purpose. The DG docket is useful in identifying the number of Distributed Energy Resources (“DER”) deployed on the system, but distribution planning has many more variables to consider than simply just DER saturation. The scope of the DG docket is too specific to address the full breadth of distribution planning considerations.

Lastly, the Department then recommends that the issue of hosting capacity be addressed by the Interconnection Workgroup. The Company does not believe that the interconnection standardization process is the best place to address hosting capacity analysis. The hosting capacity issue may be best served in the formal resource planning process, simply because this filing already addresses many of the different considerations on the distribution system. Another alternative is a new docket dedicated specifically to DER planning not unlike Xcel's current Biennial Transmission and Distribution Plan docket¹ where they have provided hosting capacity reports as part of the compliance process.

Fresh Energy

In its Comments, Fresh energy suggests that the Commission focus specifically on demand forecasts and DER scenario planning. They also assert that all utilities will benefit from integrated distribution planning, but recommend that the Commission's near-term efforts should focus on Xcel, mainly due to the scarce resources available to stakeholders at the moment. Fresh Energy encourages Minnesota Power and others to follow Xcel's dockets and learn from their experiences.

Minnesota Power appreciates Fresh Energy's thoughtfulness towards the time and resources needed to undertake a standardized distribution planning process. Once a more robust record has been developed and processes proven out, it may make sense to standardize some portions of the distribution planning process. The Company is tracking current progress in and learning from Xcel's dockets and will continue to provide distribution planning information in its Integrated Resource Plans ("IRP"), as it did in Minnesota Power's 2015 IRP.

Citizens Utility Board ("CUB")

In its Comments, CUB cautioned the Commission to verify they are able to review any mandated reports in a meaningful and expeditious way. Minnesota Power agrees that any mandated review process should not hamper the planning process. CUB also would like to view a mandate report as a prudency review and bifurcated from any cost recovery ruling. The issue of cost recovery is one that will need careful consideration. Modernization investments carry higher risks and lower life cycles than other more traditional utility investments. These additional risks are largely unrecognized within the modern regulatory compact. If the utilities are given direction to make certain investments on their systems, then there should be some certainty in cost recovery for the expected investments. Due to the nature of the uncertainty and risks around the realization of potential benefits of certain modernization investments, the current approach has been to target pilot-scale projects that incorporate optionality and scalability. This approach has yielded some tremendous benefits, including much more seamless integration of DER. This approach also allows for failures and the associated learning from those failures that comes with the modernization process.

CUB also makes the argument that cooperating with third party solution providers is against the business interests of the utilities, and that third parties will "achieve greater efficiency" in DER adoption and "squeeze extra efficiencies out of the grid," therefore lowering the need for utility investment in the

distribution system. They also advocate for more visibility for the third parties into the distribution system. CUB's assertions may be true in some territories where capacity and system limitations require system upgrades as a result of load growth; however, as noted in the Company's Comments in this docket, the vast majority of current investment is due to age-related replacements of existing systems, which would be required regardless of the presence of DER. In Minnesota Power's experience, third parties already have a reasonable amount of visibility into the distribution system and Minnesota Power has collaboratively planned all major DER projects to-date with these parties.

Interstate Renewable Energy Council ("IREC")

IREC recommends that the Commission focus on creating common statewide goals and guidance for all utilities, while allowing for some variation in timelines and other specifics, depending on each utility's particular context. They use examples of California, Missouri, New York and Ohio's grid mod planning processes throughout the document.

IREC also discusses the disconnect between the Investor-Owned Utility's ("IOU") business model/cost recovery and the advancement of the public's interest and state policy and energy goals. Minnesota Power agrees that there are improvements that could be made to modernize the current regulatory model to reflect the opportunities and challenges of today and has been an engaged participant in statewide policy discussions on this topic, including e21 stakeholder efforts and the Commission's grid modernization stakeholder meetings. IREC also alludes to a work group process similar to what we have seen in other dockets in order to facilitate stakeholder engagement. If a work group process on this topic is initiated by the Commission, as the entity responsible for the management of the distribution system and delivery of an essential service, Minnesota Power will certainly be a willing and engaged participant in the process.

In its Comments, IREC indicates concern that utilities are not currently accounting for DER's in their forecasting processes. IREC recommends that the Commission identify an ultimate goal of 8,760-hour, circuit-level forecasts that will provide additional locational and temporal precision for planning purposes. As stated in its August 21, 2017 Comments, projects within the Company's capital plan that address capacity-related needs are based on peak-load forecasts for the project area. Minnesota Power does not currently consider any DER penetration scenarios during capital budgeting as the penetration level on Minnesota Power's system is very low. Future development of large scale DER would be included in the planning process if this happens.

Finally, IREC does also recognize that a full hosting capacity analysis may not make sense for Minnesota Power and Otter Tail Power at this time. They do suggest having downloadable accessible spreadsheets that would include data such as: voltage, DER capacity, and minimum and peak load information. It is possible to make the suggested data format available to third parties, however, the data would not provide much value unless used in conjunction with supplementary system details, such as maps. Data in the suggested format would generally only benefit medium to large-scale installations, as the majority of the Company's circuits currently have low DER penetration. Minnesota Power appreciates

the recognition that Minnesota utilities have different geographic considerations, demographics and system configurations. Therefore, a one-size-fits-all approach to distribution planning is not appropriate and the Company agrees that some planning requirements may not be appropriate for all Minnesota utilities.

III. CONCLUSION

While Minnesota Power has been managing the distribution system and providing safe and reliable electricity to customers for over a century, it remains customer-focused and continually strives to include stakeholder input in its planning processes. As stated in prior Comments, the Company welcomes stakeholder input and expertise in this time of opportunity and challenge. Minnesota Power continues to place emphasis on providing safe, reliable, and affordable electric service to all customers regardless of external influences and market dynamics in this new utility landscape.
