PROPOSED DECISION OPTIONS OF GOOGLE LLC

March 27, 2026

Pursuant to the Request for Final Decisions Options issued by the Minnesota Public Utilities Commission (Commission) on March 23, 2026, Google LLC (Google) respectfully files its Proposed Decision Options in the above-captioned matter. Google appreciates the opportunity to provide its Proposed Decision Options, and state as follows:

Approve, reject, or modify

1. Large General Time of Day Service tariff; Approve with modifications.
2. Large Peak Controlled Time of Day Service tariff; Approve with modifications. The Large Peak Controlled Tariff should be modified so that the qualifications to implement a control event are based on a directive from the Midcontinent Independent System Operator or other applicable regional or federal entity overseeing the transmission system.
3. Rules for the Application of Peak Controlled Services tariff revisions; Approve.
4. Tier 1 Energy Controlled Service rider tariff revisions; Approve.
5. CIP Adjustment rider tariff revisions; Approve.

6. Administrative revisions to the Company's Tariff Book; Approve.
7. Retail Customer Form ESA; Approve with modifications.

Incremental Cost Test

8. Components of ICT and recommended modifications. The Commission should modify the tariff by removing the Incremental Cost Test ("ICT") in its entirety.
9. Alternatively, to the extent the Commission includes the ICT in the tariff, then the Commission should limit the ICT to an interim basis, and the ICT should be revisited in the next applicable general rate case. Any revenues collected above the tariff's applicable rates due to an ICT should be subject to true-up via a regulatory account, tracker, deferred accounting mechanism, or any other process that reconciles actual costs with actual revenues. To the extent an ICT is used, Xcel must properly allocate all costs, considering all costs, benefits, revenues, and expenses, and this allocation and all costs will be reviewed in a general rate case
10. Relationship to future rate cases. Large General Time of Day Service customers are assigned rates according to standard regulatory treatment of a) assessing a revenue requirement for all customers, b) identifying a just and reasonable cost allocation that assigns revenues to the appropriate classes and sub-classes, and c) designing rates for each class and sub-class in accordance with sound regulatory principles and state policy goals. Actual costs and revenues should be utilized as a basis for ratemaking in subsequent rate cases.
11. Future updates and reporting. Xcel should conduct a class cost of service study for the large customer class or subclass in each future general rate case.

Key Terms/Rate Design

12. Size Threshold. 100 MW should be approved.
13. Term Length. A 15-year contract period, inclusive of an optional 5-year load ramp should be approved.
14. Customer Charge, Demand Charge, Energy Charge. The tariff should be modified to clarify that Large Load Customers will be subject to minimum demand charges, but not minimum energy charges.
15. Changes in Contract Demand. The tariff should be modified to provide that the capacity reduction fee should be mitigated for the entire reduction period, not just 24 months.
16. Exit Fee. The tariff should be modified such that the Exit Fee is mitigated for the entire duration of the termination fee period, rather than limited to 24 months.
17. Minimum Bill. The Commission should approve the tariff's 75% minimum demand charges.
18. ESA Flexibility. The tariff should be modified to include the following term: "Nothing in the tariff prohibits Xcel and a large load customer from including additional terms or conditions, so long as such terms and conditions do not contradict the tariff and comply with the Large Load Statute."

Class Cost of Service

19. Definition of a Class or Subclass. The Commission should approve the non-discriminatory classification (100 MW and larger) for this large user class or sub-class.

20. Creation of a separate customer class. In the alternative, large load customers (100MW and larger) shall become their own class, rather than a subclass of the C&I Demand class, defined based on its service characteristics.

Regulatory Compliance

21. IRP Order and Minn. Stat. § 216B.1622. The Commission should find that Xcel's proposed terms and conditions, other than the ICT, combined with standard ratemaking practices in ongoing rate case, comply with the IRP Order and Minn. Stat. § 216B.1622. The ICT does not comply with the Commission's IRP Order Point 32 or the statute for all the reasons described in our Comments, Reply Comments and Supplemental Reply Comments.

Clean Energy and Demand-Side Management

22. CFE Procurement Program. The Commission should order the development of clean energy programs and tariffs in compliance with Minn. Stat. 216B.1623.
