

## NOTICE SOLICITING STAKEHOLDER MEMBERS

### In the Matter of Establishing Tariffs for Distribution System Cost Sharing for Interconnection in Constrained Areas

**PUC Docket Number:** E002,E015,E017/CI-24-288

**Deadline for indicating interest:** October 16, 2024

#### **Background:**

In accordance with Minnesota Session Laws – 2024, Regular Session, [Chapter 126, Article 6, Section 53](#), the Minnesota Public Utilities Commission (Commission) opened Docket E002,E015,E017/CI-24-288. The law in question is an interconnection provision, related to distribution upgrades and cost allocation.<sup>1</sup> With this notice, the Commission establishes the DER Cost Sharing Workgroup to develop standards for distribution system cost sharing for interconnection in constrained areas.

#### **Workgroup membership:**

The Commission invites requests to serve on the Reactive Cost Sharing Workgroup tasked with developing the record more fully in this docket before proposals go before the Commission for decision. Its work will be informed by national and other state learnings, anchored with technical facts, and firmly grounded in the expertise, experience, and perspectives of Minnesota’s utilities, businesses, advocates, and other interested participants.

#### Membership

Workgroup membership is open to all, but members will be divided into “Participants” or “Observers” to facilitate active, consistent, and constructive engagement. Those interested in fully and actively engaging in the Workgroup must submit a letter of request to be listed as a Workgroup Participant. The request to be a Participant should include the organization name and a brief description of the organization (or, request participation as an individual). Also, include the name(s), position(s), and contact information(s) for a lead representative, any alternate representative, and, if not the lead or alternate, a technical representative. The letter of request to be considered a Participant should also indicate agreement to the following:

1. Prepare for and attend workgroup meetings and conference calls consistently throughout each phase (see tentative schedule below);
2. Engage actively and respectfully in constructive dialogue during the issue discussions;
3. Review in a timely manner workgroup materials distributed by Commission staff provided via work group listserv or e-dockets;
4. Develop, when invited, as an organization or a member of an ad hoc subgroup, presentations and/or subtopic materials for consideration by the workgroup at upcoming meetings; and,
5. Work toward agreement where possible and, where not possible, clearly articulate differences.

The Commission may limit the number of workgroup Participants appearing on behalf of a single organization or stakeholder group.

*Observers:* Those interested in attending workshop meetings as Workgroup Observers should submit their name, organization, and contact information. Observers are welcome to attend and monitor meetings as their schedules permit and communicate their ideas or concerns to Participants for discussion or consideration by the workgroup. Observers will receive workgroup materials and may participate during public comment in the Workgroup meetings.

The meetings and conference calls/webinars are open to all interested individuals. Interested individuals can sign up on eDockets to receive notifications when new documents are filed in the associated docket (CI-24-288).

**PLEASE TAKE NOTICE** that requests to serve on the DER Cost Sharing Workgroup as a Participant or Observer are due no later than October 16, 2024. Requests must be e-filed in the Commission's eDockets system. The Commission anticipates confirming the initial Workgroup roster by October 25, 2024.

### Proceeding Phases

Staff envisions this docket proceeding in three phases.

Phase One includes a shorter joint stakeholder meeting with the Proactive Grid Upgrade Workgroup (Docket 24-318) to discuss the distinction between the two groups including the expected scope, timelines, and crossover between the workgroups, as well as scenarios when proactive vs reactive upgrades would be utilized. Phase One will also include an initial meeting to determine the procedural path specific to the DER Cost Sharing Workgroup.

Phase Two of this proceeding will discuss the technical details of the legislation. The purpose of this phase is for the participants to have open communication over key issues before submitting written comments. Due to the complexity of this topic, it may be advantageous for participants to identify areas of consensus, disagreement, and compromise in this phase so that the comments submitted into the record can be focused on outstanding differences.

Phase Three of the proceeding will include a Notice of Comment and formal record development based on the information gained in Phase Two followed by an agenda meeting and Commission decision. The DER Cost Sharing Workgroup may decide on some variation of this proceeding in phase two, such as submitting a proposal, then initial and reply comments.

All meetings will be done in a hybrid format with the in-person locations tentatively placed in the PUC Large Hearing Room accompanied with a Webex option for online participation. In person participation is encouraged.
