Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits this letter to the Minnesota Public Utilities Commission in response to comments submitted by the Department of Commerce and Center for Energy and Environment (CEE) in the above-referenced docket.

CEE supports the Company's request to withdraw its filing and plans to work with stakeholders to address questions we have received in response to our Notice. The Department recommends that the Commission accept the Company's request to withdraw its Notice of New Non-Regulated Offerings and expressed its concern that issues in this docket may impact the Company's forthcoming rate case. The Department noted that plans to refile should be contingent upon the Company meeting with interested parties, filing a status report by August 20, 2021, and submitting an updated filing by September 1, 2021.

The Company plans to meet with stakeholders, including CEE and the Department, in the coming weeks to further discuss the questions we received in response to our Notice. Once those discussions have occurred, we plan to incorporate the feedback we received into our amended filing. While the Company will make every effort to submit an amended filing by September 1, 2021, we are concerned that this timing may not allow sufficient time to fully resolve the questions that have been raised. Therefore, we ask that the

Commission not impose a requirement that we submit our amended filing on or before September 1, 2021. However, we understand the Department's concern and, therefore, the Company commits to addressing how the issues in this docket impact our rate case in our amended submission. The Company also agrees to the Department's recommendation to file a status report no later than August 20, 2021.
