Dear Mr. Seuffert:

The Delano Water, Power and Light Commission, doing business as Delano Municipal Utilities (DMU) submits this letter to the Minnesota Public Utilities Commission (the Commission) as a compliance filing in this docket.

In past years, DMU was a member of a municipal power agency, the Central Municipal Power Agency/Services (CMPAS), which completed filings related to this docket on behalf of DMU. Because DMU withdrew as a member of CMPAS effective May 9, 2024, DMU is now considered an "electric utility" under Minnesota Statutes, Section 216B.1691, subd. 1(d)(5), as a municipal utility that is not a member of a municipal power agency.

This letter provides notice to the Commission, pursuant to the Commission's December 6, 2023 Order in this matter, that DMU has become an electric utility subject to Section 216B.1691. DMU requests that the Commission update its records as appropriate, including issuing any revisions to its orders, and adding DMU to the service list. Contact information is listed below.

DMU will comply with the applicable reporting requirements of an electric utility under Section 216B.1691, effective May 9, 2024.
