Dear Ms. Bergman:

On October 16, Administrative Law Judge Ann C. O'Reilly issued her report recommending the Commission review and approve the settlement agreement reached by the parties in the above-referenced matter. Under Minn. R. 7829.2700, parties have 15 days to file exceptions to an ALJ report subject to statutory deadlines.

The Minnesota Department of Commerce has no exceptions to Judge O'Reilly's report. The Commission should approve the settlement agreement achieved by the parties. As the Administrative Law Judge's report recognizes, the settlement is consistent with the public interest and supported by substantial evidence.

The settlement provides substantial value to Dakota Electric Association's members. The settlement limits the Association's overall revenue requirement increase to \$20.881 million, representing an average 9.62% increase. This increase is smaller than the 11% increase requested in the Association's initial filing. The return on equity, overall cost of capital, and overall return on rate base reflect the Department's proposed adjustments to the calculation of the Association's capital structure. As part of settlement discussions, the Association provided the parties with additional support for its test year compensation expense. This additional information allowed the parties to reach agreement on more accurate test year compensation expense adjustments than would have been possible based on the initial filing.

The Department reviewed the Association's financial schedules as part of the settlement. The Commission should approve them. The Department does not believe there are any other issues that require the Commission's attention at this time.

The Department appreciates this opportunity to reiterate its support for the settlement agreement, and thanks Judge O'Reilly for her thorough review of the record and of the settlement.
