Notice of Approval of C-BED Project

On August 30, 2006, Xcel Energy filed a proposed Power Purchase Agreement (PPA) between itself and Jeffers Wind 20, LLC, a Community-Based Energy Development (C-BED) project with the Minnesota Public Utilities Commission. Under Minn. Stat. § 216B.1612, subd. 7(e), if no objection is received within thirty days, the PPA is deemed approved by the Commission.

On September 29, 2006, the Department of Commerce filed comments recommending that the PPA be approved, with certain addenda.

On October 24, 2006, Xcel Energy filed a revised PPA, consistent with the Department's recommendations. Based upon this filing date, a new comment period, expiring November 27, 2006, began. No objections to the PPA were received.

Take notice that, due to the expiration of the approval period specified by Minn. Stat. § 216B.1612, subd. 7(e), the PPA for the Jeffers Wind 20, LLC is deemed approved.

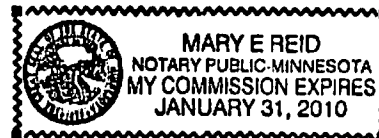
