Dear Mr. Wolf:

In our September 3, 2014 Petition in the above-mentioned Docket, Northern States Power Company, doing business as Xcel Energy, submitted a request for approval of two Administrative Services Agreements with newly formed transmission-only (Transco) affiliates. In our September Petition, we proposed to submit Compliance Filings on May 29, 2015 and May 31, 2016 which would provide a report of certain Service Company and direct Northern States Power Company-Minnesota (NSPM) costs billed to the Transco work orders in 2014 and 2015.

In their January 16, 2015 Comments, the Department of Commerce, Division of Energy Resources agreed this level of reporting is appropriate. The Commission has not yet acted on our Petition. If the Commission adopts our Compliance Filing proposal, we now propose to submit our first Compliance Filing thirty (30) days after the Commission issues an order in this Docket, rather than on May 29, 2015.

We have electronically filed this document with the Minnesota Public Utilities Commission, and copies have been served on the parties on the attached service list.
