**APPLICATION OF CHARTER FIBERLINK CC VIII, LLC  
TO AMEND CERTIFICATE OF AUTHORITY**

COMES NOW Charter Fiberlink CC VIII, LLC (“**Charter Fiberlink CC VIII**” or “**Applicant**”) and hereby requests that its Certificate of Authority issued by the Minnesota Public Utilities Commission (the “**Commission**”) be amended to permit Charter Fiberlink CC VIII to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services to residential and business customers in additional exchanges and rate centers in the State of Minnesota, as described herein.

In support of its Application, Charter Fiberlink CC VIII states as follows.

1. **Identity of Applicant.** Charter Fiberlink CC VIII is a limited liability company organized under the laws of the State of Delaware and is an indirect, wholly-owned subsidiary of Charter Communications, Inc. Charter Fiberlink CC VIII’s address for purposes of this proceeding is 12405 Powerscourt Drive, St. Louis, Missouri 63131.

**2. Description of Certificates of Authority Currently Held by Charter Fiberlink**

**CC VIII.** On August 17, 2009, the Commission granted a Certificate of Authority to Charter Fiberlink CC VIII in Docket No. P5615/M-09-239 to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in the following exchanges and rate centers:<sup>1</sup>

- (i) Bemidji, Cass Lake, St. Cloud, St. Joseph, Duluth, Northfield, Twin Cities Metropolitan Service Area, Little Falls, Sauk Centre, Marshall, Montevideo, Willmar, Rochester, Stewartville, Winona, Faribault, Owatonna, Albert Lea, Austin, Brainerd, Glenwood, Nisswa, Park Rapids, Red Wing, Staples, Tracy, Wadena and Fergus Falls, served by Qwest Corporation;
- (ii) Cokato, Osseo, Eyota, Benson, Aitkin, Alexandria, Browerville, Crosby, Deerwood, Long Prairie, Lewiston, Rollingstone and Bennetville, served by Embarq Minnesota, Inc. (now Embarq Minnesota, Inc. d/b/a CenturyLink);
- (iii) Mound, Byron, Cottonwood, International Falls and Ranier, served by Citizens Telecommunications Company of Minnesota, LLC, d/b/a Frontier Citizens Communications of Minnesota;
- (iv) Apple Valley, Rosemount, Lakeville, Fairmount and Farmington, served by Frontier Communications of Minnesota, Inc.;

Also as set forth in the application, and as recognized by the Commission in its order, Charter Telephone of Minnesota, LLC's predecessor, in Docket No. P-5615/NA-98-1512, acquired local niche authority for a number of exchanges served by Qwest Corporation, Mankato Citizens Telephone Company, Embarq Minnesota, Inc., Blue Earth Valley Telephone Company, Melrose Telephone Company and Eagle Valley Telephone Company.



(v) Mankato, served by Mankato Citizens Telephone Company; and

(vi) Eagle Lake, served by Mid-Communications, Inc. d/b/a HickoryTech.

On June 2, 2010, the Commission granted a Certificate of Authority to Charter Fiberlink CC VIII in Docket No. P5615/M-10-427 to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in the Dassel exchange and rate center served by Embarq Minnesota, Inc. d/b/a CenturyLink.

On March 21, 2012, the Commission granted a Certificate of Authority to Charter Fiberlink CC VIII in Docket No. P5615/M-12-132 to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in the Monticello exchange and rate center, which is served by Bridge Water Telephone Company d/b/a TDS Telecom.

On May 22, 2012, the Commission granted a Certificate of Authority to Charter Fiberlink CC VIII in Docket No. P5615/M-12-392 to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in the following additional exchanges and rate centers:

(i) La Crescent, served by Ace Telephone Association;

(ii) Kasson, served by Kasson-Mantorville Telephone Company;

(iii) New London and Spicer, served by Mid-State Telephone Company d/b/a TDS Telecom; and

(iv) Big Lake and Maple Lake, served by Windstream Lakedale, Inc. (including as successor to the assets of Sherburne County Rural Telephone Company).

On January 11, 2016, the Commission granted a Certificate of Authority to Charter Fiberlink CC VIII in Docket No. P5615/SA-15-85 to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in following exchanges and

rate centers served by Arvig Telephone Company d/b/a TDS Telecom: Breezy Point, Ideal Corners, Pequot Lakes, and Pine River.

On June 8, 2016, the Commission granted a Certificate of Authority to Charter Fiberlink CC VIII in Docket No. P-5615/SA-16-375 to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in the Backus and Hackensack exchanges and wire centers served by Arvig Telephone Company d/b/a TDS Telecom and the Altura exchange and rate center served by Embarq Minnesota, Inc. d/b/a CenturyLink.

On September 7, 2016, the Commission granted a Certificate of Authority to Charter Fiberlink CC VIII in Docket No. P-5615/SA-16-599 to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in the Kandiyohi exchange and rate center served by Citizens Telecommunications Company of Minnesota, LLC and the Hastings exchange and rate center served by Embarq Minnesota, Inc. d/b/a CenturyLink.

Pursuant to its local facilities-based authority, Charter Fiberlink CC VIII currently provides or will provide facilities-based local exchange and private line telecommunications services in the aforesaid exchanges and rate centers.<sup>2</sup>

**3. Request for Amendment to Certificate of Authority.** Charter Fiberlink CC VIII requests that the Commission issue an amended Certificate of Authority permitting Charter Fiberlink CC VIII to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services to residential and business customers in the

The Affidavit of Service regarding Charter Fiberlink CC VIII's service of the notice is attached to this Application at Exhibit "B."

**4. Interconnection Agreement.** Through Charter Fiberlink CCO, LLC, which is affiliated and shares a common management team with Charter Fiberlink CC VIII, interconnection arrangements have been made or are being made (whether by negotiation or adoption request) with other incumbent local exchange carrier(s), including for the purpose of permitting the exchange of extended area service (as applicable) initiated by or terminated to customers in the service areas described herein.

**5. Managerial, Technical and Financial Capability.** Charter Fiberlink CC VIII possesses sufficient business experience and technical, managerial and financial capability to provide facilities-based local exchange services, resold local exchange services, interexchange services and local niche services in the proposed service areas for which Charter Fiberlink CC VIII

requests authority in this Application. Charter Fiberlink CC VIII currently provides local exchange and private line telecommunications services to customers located in the exchanges and rate centers for which the Commission, as aforesaid, granted approvals on August 17, 2009, June 2, 2010, March 21, 2012, May 22, 2012, January 11, 2016, June 8, 2016 and September 7, 2016.

### **CONCLUSION**

Charter Fiberlink CC VIII respectfully requests that the Commission, consistent with the public interest, grant authority to Charter Fiberlink CC VIII to provide facilities-based local exchange services, resold local exchange services, interexchange services, and local niche services in the additional exchanges and rate centers described in this Application. Charter Fiberlink CC VIII also requests that the Commission grant such other or additional relief that the Commission deems just and proper.


