Department of Commerce, Energy Environmental Review and Analysis (EERA) staff has completed the environmental assessment scoping process in the following matter:

In the Matter of the Application of Dairyland Power Cooperative for a Route Permit for the Beaver Creek 161 kV Transmission Line Project in Fillmore County, Minnesota.

The scoping period for the environmental assessment (EA) was open from October 22, 2024, through December 3, 2024. Public meetings for the project were held on November 12 and November 13, 2024. Verbal and written comments were received from the general public, the Minnesota Department of Natural Resources, and the applicant. None of the commentors suggested an alternative route or route segments for the proposed 3.5-mile Beaver Creek 161 kV transmission line project in Fillmore County, Minnesota.

Accordingly, EERA staff recommends that the Commission authorize EERA to include in the scoping decision for the EA solely the route for the project identified by Dairyland Power Cooperative in its route permit application. EERA staff is available to answer any questions the Commission may have.
