Dear Mr. Seuffert:

Great River Energy has reviewed the Findings of Fact, Conclusions of Law, and Recommendations ("Report") filed by the Administrative Law Judge on August 4, 2023, in the above-captioned matter. Great River Energy appreciates the Administrative Law Judge's thorough Report and the recommendation that a route permit be issued for the Project. Great River Energy does not have any exceptions to the Report.

Previously, Great River Energy and the Department of Commerce, Energy Environmental Review and Analysis ("DOC-EERA") disagreed regarding whether Condition 6.3 of the Route Permit (regarding a vegetation management plan) should explicitly acknowledge that landowner preferences would be part of the vegetation management plan. Great River Energy believed that Condition 6.3 should specifically recognize that landowner preferences would be included in the vegetation management plan.<sup>1</sup> In response, DOC-EERA stated: "EERA believes that building landowner goals and associated objectives into the VMP allows GRE to meet their goal of accommodating landowner requests for site restoration along the transmission route while preserving the technical function of the vegetation management plan."<sup>2</sup> In the Report, the Administrative Law Judge recommended that the Minnesota Public Utilities Commission ("Commission") approve Condition 6.3, as written by DOC-EERA, stating: "The Administrative Law Judge agrees with EERA that landowner preference is appropriate as a vegetation

management plan goal and recommends not including recognition of landowner preferences in the route permit."<sup>3</sup>

For the reasons previously explained in this record, Great River Energy continues to believe that it is important that any vegetation management plan acknowledge and accommodate landowner preferences.<sup>4</sup> Because DOC-EERA's comments and the Report reflect agreement on this point, Great River Energy believes that the record in this matter is clear that landowner preferences may be included in the Project's vegetation management plan and, accordingly, does not submit exceptions to the Report.
