Background:

On October 31, 2025, the Minnesota Transmission Owners filed the 2025 Biennial Transmission Project Report (Report) with the Minnesota Public Utilities Commission (Commission) as required in Minn. Stat. § 216B.2425.

The Report is required to list specific present and reasonably foreseeable future inadequacies in the transmission system in Minnesota. The Report must also identify alternative means to address the inadequacies listed, including the utilization of grid-enhancing technologies, and identify potential issues (economic, environmental, and social) with each alternative.
