**Topics Open for Comment:**

- To the extent possible, have the areas affected by pipeline construction been restored to the natural conditions that existed immediately before construction of the pipeline in accordance with the pipeline routing permit?
- Should the Commission accept or reject the certification of completion?
- Are there any costs or reimbursements due?

**Background:** On October 27, 2023, the Commission issued a pipeline routing permit to Heartland Corn Products (HCP) for its Heartland Corn Natural Gas Pipeline Project in Sibley County. On August 18, 2025, Heartland Corn Products filed a letter with the Commission certifying that construction of the Project has been completed in compliance with landowner agreements and all permit conditions pursuant to Minn. R. 7852.3900 and requested that the Commission make a determination on the certification of completion and on any costs or reimbursements due.

If the Commission accepts the certification, the Commission's jurisdiction over the pipeline routing permit will be terminated.
