- Are there any other customers similarly situated to the customer who filed comments with the Commission on December 5, 2014?
- What response have the utilities provided to the customer?
- Did the customer notice submitted by Delano in the record on November 12, 2014, which stated that “we do not expect a disruption in your service other than a brief disruption in your electric service during the switch over,” adequately inform the Commission and affected customers?
- Any other relevant issues.

Project Background: On September 26, 2014, Delano Water, Light, and Power Commission (Delano) and Wright-Hennepin Cooperative Electric Association (W-H) filed a joint request to modify their electric service territory boundaries. On December 5, 2014, a customer affected by the boundary change filed comments stating that she has invested \$4,000 to install an off peak water heater and air conditioner. She was informed that Delano, as her new utility, will no longer be offering the off peak programs, the equipment would be removed from her home, and that it is not clear who will bear the cost for these changes.

Filing Requirements: Utilities, telecommunications carriers, official parties, and state agencies are **required** to file documents using the Commission's electronic filing system (eFiling). All parties, participants and interested persons are encouraged to use eFiling: mn.gov/puc, select *eFiling*, and follow the prompts.
