**STIPULATION AND SETTLEMENT AGREEMENT

STIPULATION AND SETTLEMENT AGREEMENT
AND
AGREEMENT FOR SERVICE BY EXCEPTION

This Stipulation and Settlement Agreement and Agreement for Service by Exception (“Settlement and Service Agreement”) is entered into February 1, 2016 by and between Otter Tail Power Company, a Minnesota corporation (“OTP”) and PKM Electric Cooperative, Inc. a Minnesota cooperative (“PKM”) (individually “Party” and collectively “Parties”).

RECITALS:

- A. OTP and PKM are parties to Minnesota Office of Administrative Hearings Docket No. 5-2500-32357, Minnesota Public Utilities Commission (“Commission”) Docket No. E131, E017/C-15-176 (the “Proceeding”).
- B. OTP has provided all high voltage service (defined as 41.6 kV or above) to all electric-powered pumps and related equipment of Enbridge Energy, Limited Partnership (“Enbridge”) located within the fenced perimeter (as of December 31, 2014) of a site legally described on Attachment 1 and shown on Attachment 2 (the “Original Site”);
- C. The Proceeding involved a dispute as to whether OTP or PKM has the right to provide high voltage service to the electric-powered pumps and related equipment that have been installed by Enbridge to serve the Enbridge Line 67 on a site legally described on Attachment 1 and shown on Attachment 2 (the “New Site”);
- D. The Proceeding also identified potential issues regarding whether OTP or PKM would have the right to provide high voltage service to new electric-powered pumps and related equipment that may be installed (including such pumps and equipment to serve Enbridge Line 3), on the New Site or on other parcels of real estate that may be located, in whole or in part, within one-half (1/2) mile of the intersection of Minnesota Highway 11 and Township Road 111 (227/240th Avenue), as shown on Attachment 3, including any sites that are contiguous to the Original Site, irrespective of road right-of-ways (all such other parcels of real estate being referred to as “Other Possible Donaldson Sites”); and

NOW THEREFORE IT IS AGREED:

3. Dismissal of Proceeding. The Parties also agree that the Proceeding shall be dismissed with prejudice, except that the Proceeding shall be reopened and continued at the ALJ decision-

making stage in the events that (1) the Commission takes any action to reject or modify all or any part of this Settlement and Service Agreement and (2) either Party determines that this Settlement and Service Agreement is null and void, as contemplated in Section 6 of this Agreement. The Parties agree to jointly file a Stipulation for such a Dismissal and to work together to take any additional steps needed to obtain such Dismissal.

4. Service-by-Exception Agreement. Pursuant to Minn. Stat. § 216B.40 and subject to the terms and conditions described herein, PKM consents to OTP's past, present and future high voltage service to Enbridge (including its successors and assigns) for electric-powered pumps and related equipment at the Original Site, the New Site, and Other Possible Donaldson Sites and agrees that OTP shall be the exclusive and permanent provider of high voltage service to Enbridge (including its successors and assigns) for any and all electric-powered pumps and related equipment installed by Enbridge (including its successors and assigns) at the Original Site, the New Site, and Other Possible Donaldson Sites.

5. Recording. OTP shall take reasonable steps to have the service by exception arrangement for high voltage service for electric-powered pumps and related equipment at the Original Site, the New Site, and Other Possible Donaldson Sites recorded on the Commission's official service area maps, and PKM shall cooperate with OTP in making such request. This service-by-exception agreement does not extend beyond high voltage service to Enbridge for electric-powered pumps and related equipment at the Original Site, New Site, and Other Possible Donaldson Sites, and by entering into this service by exception arrangement, PKM neither consents to nor agrees that OTP has the right to extend electric service to any other Enbridge operations located anywhere else within PKM's assigned service territory as to which both PKM and OTP shall have all rights under applicable Minnesota law.

6. No Conditions or Modification. The Parties agree that this Settlement and Service Agreement is not subject to any further conditions. In the event that the Commission takes any action to reject or modify all or any part of this Settlement and Service Agreement, either Party may, in its sole discretion determine that this Settlement and Service Agreement is null and void. In such event, this Settlement and Service Agreement: (1) shall not be any part of the record in the Proceeding or be cited or have any precedential effect in the Proceeding or any other proceeding; and (2) shall not limit either Party's rights to take different positions in the Proceeding or any other proceeding.

7. Reservation of Rights. Except as specifically set forth herein, this Settlement and Service Agreement does not modify or limit the legal rights of any party.

8. No Precedent. The Parties recognize that this Settlement and Service Agreement reflects the unique facts of this case and is the result of negotiations between the Parties, and that this Settlement and Service Agreement does not represent the position of either Party as to the appropriate application of the law determining electric service territory rights, the determination of compensation in such matters, or any binding or legal precedent on any Party in any other matter.

9. Trade Secret. This Settlement and Service Agreement contains information concerning OTP that has significant economic value to OTP as a result of not being generally known to, and

not being readily ascertainable by proper means by other persons and is subject to efforts by OTP to protect the information from public disclosure. OTP maintains that the information designated herein as Trade Secret meets the definition of Trade Secret Information and Proprietary Information within the meaning of Minn. Rule 7829.0500 and Minn. Stat. § 13.37; provided, however, OTP may choose to disclose such information designated Trade Secret at one or more times in the future, and either Party may disclose such information designated Trade Secret subject to the conditions set forth in Section 10 (f) of this Settlement and Service Agreement.

10. Miscellaneous.

- a. Entire Agreement and Modification. This Settlement and Service Agreement contains the entire agreement and understandings of the Parties hereto regarding the scope of the Settlement and Service Agreement. No amendment, modification or waiver of, or consent with respect to this Settlement and Service Agreement shall be effective unless in writing and signed by all Parties.
- b. Binding on Successors and Assigns. This Settlement and Service Agreement will inure to the benefit of the Parties hereto and shall be binding on them and their respective legal representatives, successors, assigns, predecessors, parent corporations, affiliated corporations and entities.
- c. Assignment. No Party shall transfer or assign any of its rights hereunder, voluntarily, involuntarily or by operation of law, without the prior written consent of the other Party, which consent will not be unreasonably withheld; provided that consent shall not be required for a transfer or assignment in connection with a merger or transfer of all or substantially all assets of a Party.
- d. Agreement Drafted Jointly. Both Parties shall be deemed jointly responsible for drafting all and any portion of this Agreement.
- e. Cooperation and Other Steps. The Parties agree to fully cooperate with each other in the implementation of this Settlement and Service Agreement, and to take such additional steps and actions, including but not limited to the execution of instruments and other documents, supplying of information and cooperating in proceedings, as may be reasonably necessary to carry out the intent of this Settlement and Service Agreement.
- f. Confidentiality. The terms of this Settlement and Service Agreement are confidential and the Parties acknowledge that confidentiality is a material and critical term of this Settlement and Service Agreement. Subject to the provisions of Section 9, both Parties agree to maintain and protect the confidentiality of this Settlement and Service Agreement and agree not to disclose the terms of this Settlement and Service Agreement except: (i) to the Parties to the Proceeding as of the date hereof, (ii) to PKM's Board of Directors, PKM's power supplier, PKM's expert consultant, Dennis Eicher, and PKM's legal, tax, and accounting advisors, who shall execute an agreement as set forth on Attachment 4 and shall not disclose or use the Trade Secret Information for any purpose other than this

Proceeding or advising a Party to this Proceeding; and (iii) as required to enforce this Settlement and Service Agreement or as required by law pursuant to an applicable court or regulatory order, and then only under the terms of a protective order or protective agreement after providing the other Party with the opportunity to object and take action to prevent disclosure of the Settlement and Service Agreement. Subject to the provisions of Section 9, the Parties shall take all necessary and appropriate steps to maintain the confidentiality of the OTP-designated Trade Secret Information and Proprietary Information contained herein.

- g. Counterparts. This Settlement and Service Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which taken together shall constitute a single Settlement and Service Agreement.

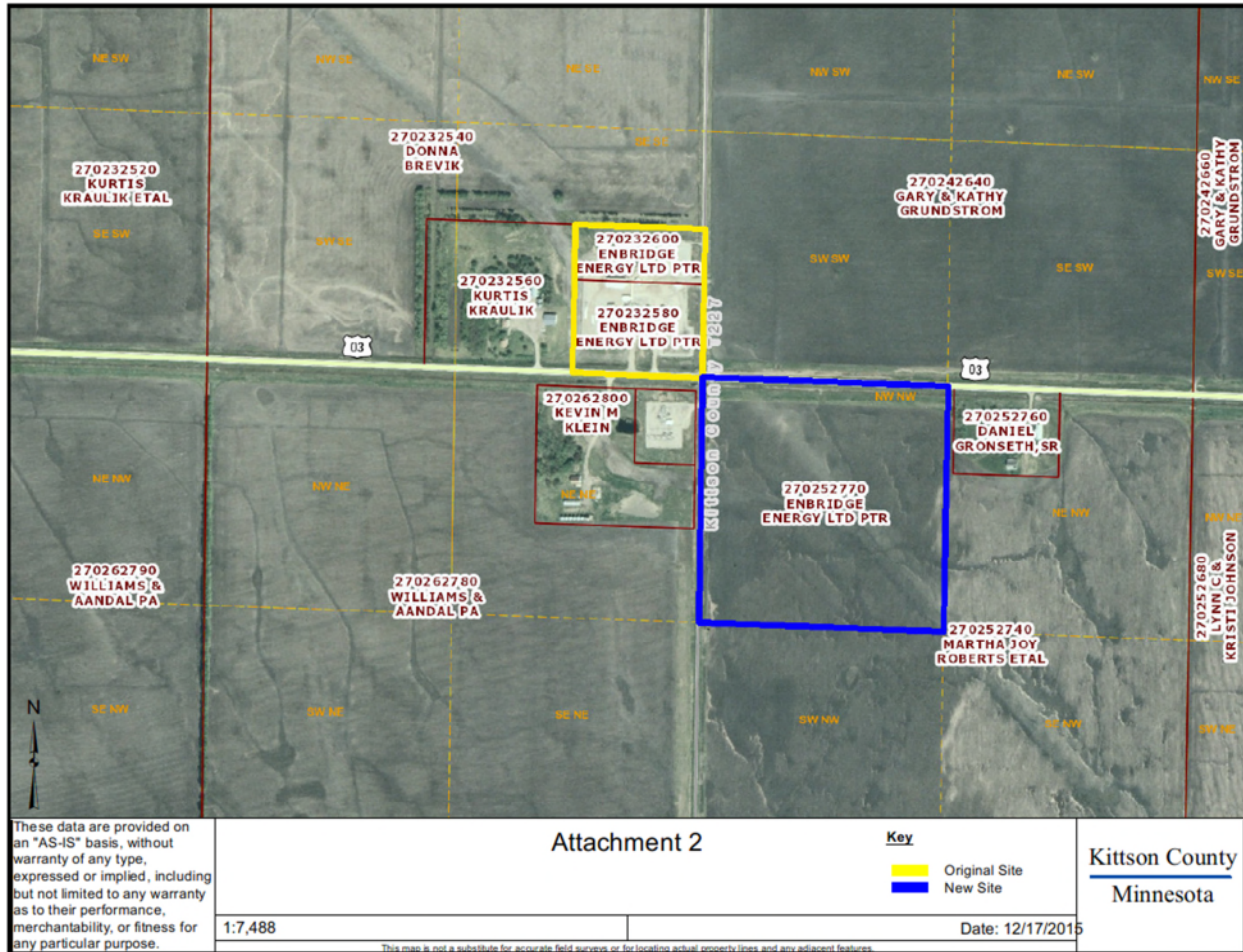

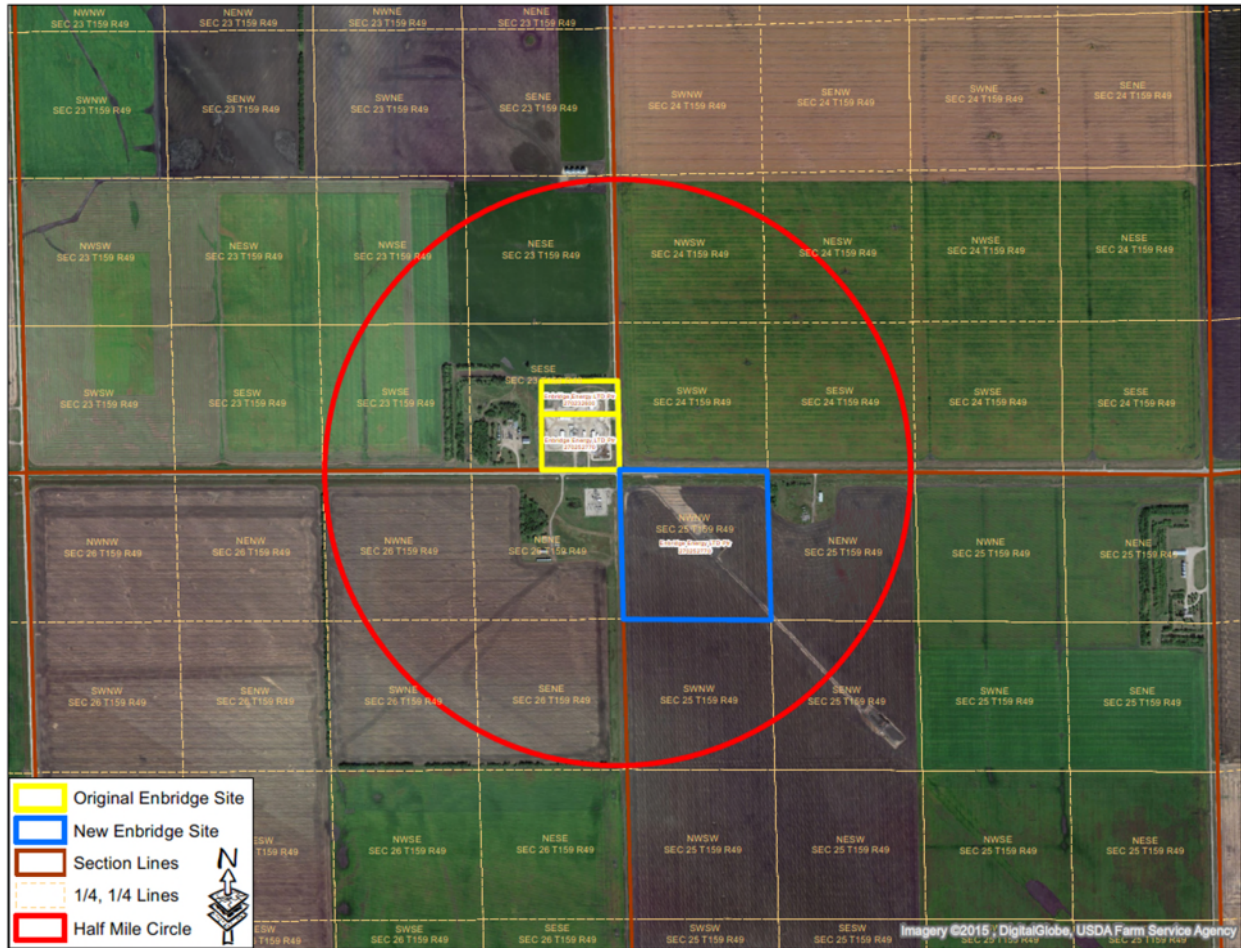
Attachment 2


