On April 27, 2017, administrative law judge Barbara Case ("ALJ") filed her Findings of Fact and Conclusions of Law ("Report") and recommended that the Minnesota Public Utilities Commission ("Commission") issue a site permit to Red Pine Wind Project, LLC ("Red Pine") to construct and operate the up to 200.1 MW Red Pine Wind Project in Lincoln County, Minnesota ("Project"). Red Pine appreciates the ALJ's recommendation as well as the thoroughness and quality of her Report.

Red Pine supports the recommendations set forth in the Report, including the changes to the Project's Draft Site Permit recommended in paragraph 6 of the Conclusions of Law. In addition, Red Pine offers the following updates to the ALJ's Report based on filings made after the Report was issued:

- Red Pine filed an updated version of the Project's Avian Bat Protection Plan on May 12, 2017. Thus, the blank date in Section 7.5.1 of the Draft Site Permit (as recommended for revision by the Department of Commerce Energy Environmental Review and Analysis staff) could be revised to reference this May 13, 2017 date.
- In addition, Red Pine also recently filed a Prairie Protection and Management Plan, a Potential Native Prairie Assessment, a Wetland Delineation Report, and a Phase I Archaeological Reconnaissance Survey Report.
