Dear Mr. Wolf:

Northern States Power Company, doing business as Xcel Energy, respectfully requests the Minnesota Public Utilities Commission grant the Company a three-month extension to submit its 2015 Review of Remaining Lives Petition. The Commission's June 16, 2014 Order in Docket No. E,G002/D-14-181 requires that the Company submit its next filing by February 17, 2015. We ask that the due date be extended to May 18, 2015.

The Company is requesting an extension in order to allow the Commission to rule on two open dockets that will affect this 2015 remaining lives review. The two dockets are the Company's 2013 Electric Rate Case, Docket No. E002/GR-13-868, and Docket No. E,G999/CI-13-626, Decommissioning Cost Investigation.
