PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold a remote-access public meeting on the applications of Nobles Wind Farm for their proposed Large Wind Energy Conversion System (LWECS) site permit amendment. **Due to the current COVID-19 pandemic, the remote-access public meeting will replace the standard in-person meeting.** The purpose of the meeting is to provide information about the proposed projects and the application review process, to obtain public input on the proposed projects, and to compile the record for the Commission to consider in making a final decision on the permit amendment.

Project Description

The Nobles Wind Farm facility is an existing 201 megawatt (MW) LWECS located in Nobles County, Minnesota. The project received a site permit on December 11, 2009. The site permit was amended and transferred to Xcel Energy on August 25, 2010.

Xcel Energy is requesting permit amendments to allow for upgrades to the LWECS facility. The upgrades would consist of replacing equipment within the nacelle, and turbine base (gearboxes and associated components) and replacing the rotor assembly which includes the installation of longer turbines blades. One turbine will be decommissioned and moved 100 feet east of its current location. The upgrades would increase the existing turbine rotor diameter from 77 meters to 91 to 97 meters, depending on the turbine used. The upgraded turbines would increase the nameplate capacity to 217 MW, though the energy delivered to the power grid would not exceed the 201 MW capacity at the point of interconnection. The site permit amendment proposes to reduce the project boundary from 25,525 acres to 23,912 acres. Specifically, Xcel Energy has requested the following amendments to the site permit:

- Increase the nameplate capacity to 217 MW;
- Extend the site permit expiration date to 25 years from the amended site permit issuance date;
- Grant waivers for the wind access buffer setbacks for up to 63 turbines;
- Update permit language to be consistent with recent LWECS projects;
- Installing a lighting mitigation system; and
- Reduce the permitted project boundary.

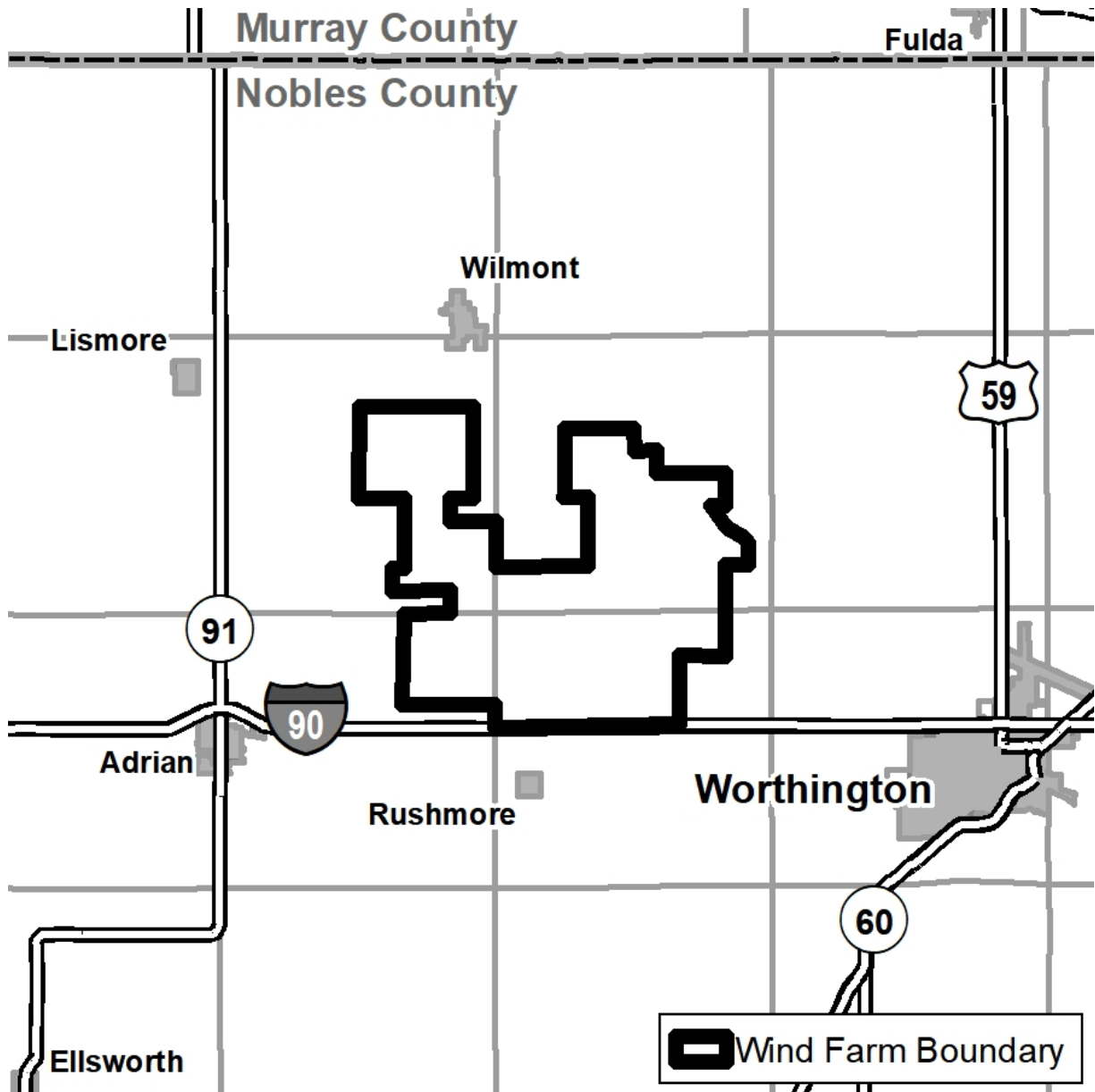
