The Energy Facility Permitting Unit of the Department of Commerce recently completed a review of the referenced permit's requirements for the Glacial Ridge Wind Project and compared them to filings on the Department of Commerce e-Docket website. We are implementing a new compliance tracking system for these permits.

We are aware that this project has not yet proceeded to construction, but are providing the attached summary of permit requirements to help you to fulfill the permit's expectations.
