Plum Creek Wind Farm, LLC (Plum Creek) respectfully submits this response to comments submitted by the Minnesota Department of Commerce, Energy and Environmental Analysis unit (EERA) during the supplemental comment period established in the Minnesota Public Utilities Commission's (Commission) Notice of Comment Period on Request to Amend Permits ending on March 17, 2025, for the Plum Creek Wind Farm Project (Project). Plum Creek is amenable to the decommissioning plan revisions proposed by EERA and, accordingly, all comments raised during the comment period have been addressed and the amendments are ready for Commission approval.

In its supplemental comments EERA noted the agreement between the Minnesota Department of Natural Resources (DNR), Plum Creek and EERA on the DNR's requested and EERA's recommended permit conditions addressing natural resource concerns.² The requested permit conditions are included in the revised permits included in Plum Creek's reply comments. EERA acknowledged that Plum Creek filed the supplemental information requested by EERA in its initial comment letter.³ EERA also recommended that Plum Creek make changes to several portions of the draft decommissioning plan for the Project.⁴
