PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) has issued the Final Environmental Impact Statement (EIS) for Xcel Energy’s proposed Mankato – Mississippi River Transmission Line Project (MMRT). The proposed project includes: (1) a new approximately 130-mile long 345 kilovolt (kV) transmission line between the existing Wilmarth Substation in Mankato and the Mississippi River near Kellogg, and (2) a new approximately 20-mile long 161 kV transmission line between the existing North Rochester Substation near Pine Island and an existing transmission line northeast of Rochester.

The Final EIS analyzes the potential human and environmental impacts of the project and possible measures to mitigate these impacts. It analyzes routing alternatives that could be used for the project and provides a comparative analysis of routing options. The Final EIS responds to the comments received on the Draft EIS for the project. The Final EIS will be used by the Commission in deciding whether to issue a certificate of need and route permit for the project.

Additional Information

References to Staff. On July 1, 2025, Department of Commerce Energy Environmental Review and Analysis (DOC EERA) staff moved to the Minnesota Public Utilities Commission Energy

Infrastructure Permitting (PUC EIP) unit as directed by state law (Laws of Minn. 2024, ch.126, art. 7). While EERA staff initiated environmental review of this project prior to July 1, 2025, the environmental review is now being completed by PUC EIP staff. For accuracy related to procedural history, references to previous filings by EERA will be identified as such. The Final EIS does include references to EERA and EIP, and these should be considered interchangeable throughout the document.
