### In the Matter of a Commission Evaluation of Changes to Natural Gas Utility Regulatory and Policy Structures to Meet State Greenhouse Gas Reduction Goals

PUC Docket Number(s): **G999/CI-21-565**

**Issue:** What action(s), if any, should the Commission take to modify existing gas line extension policies for rate regulated gas utilities?

#### Topic(s) Open for Comment:

- Should the Commission consider any modifications to how gas utilities calculate free footage allowance and other costs related to gas main and service line extensions? If so, what factors or conditions would justify changes? And how would any proposed changes affect new connecting customers and other ratepayers?
- If the Commission should make modifications to regulated gas utilities' gas line extension policies, how would rules, statutes, and Commission orders justify those modifications?
- Which proposed modifications, if any, would necessitate gas utilities to coordinate and/or consult with electric utilities in the service territory where a gas line extension is being contemplated?
- How should the Commission consider the results of Minnesota Energy Resource Corporation's [Line Extension Policy Study](#)<sup>1</sup> in this matter?
- What lessons should the Commission consider from proceedings in other states related to this matter?
- Should any distinctions be made between different customer classes when considering modifications?

- How should the Commission consider the needs of low-income customers and other areas of equity in this matter?
- Are there other issues or concerns related to this matter?

### **Background**

In 2021, the Minnesota Legislature directed the Commission to initiate a proceeding to evaluate changes to natural gas utility regulatory and policy structures needed to meet or exceed Minnesota's greenhouse gas emissions reduction goals.<sup>2</sup> The Commission opened Docket G999/21-565 to meet this directive, referring to this docket as "The Future of Gas." After a series of technical workshops in the Future of Gas docket, the Commission and stakeholders focused on establishing frameworks for natural gas utilities' Integrated Resource Plans (IRPs).<sup>3</sup> Following stakeholder engagement and several rounds of comments, the Commission established filing requirements for gas IRPs in Orders issued on March 27 and October 28, 2024, in Docket No. G008,G002,G011/CI-23-117. As a result, the Commission and stakeholders now have an established process to consider gas utility practices around energy provision and capacity expansion planning.

In this Notice of Comment, the Commission now aims to address gas line extension policies, which have been discussed in various Commission proceedings both in the Future of Gas docket and outside of it. Minn. Stat. § 216B.04 directs that "every public utility shall furnish safe, adequate, efficient, and reasonable service; provided that service shall be deemed adequate if made so within 90 days after a person requests service." Thus, gas utilities have policies that govern how they will respond to requests for new service. This includes gas line extension allowance policies, which are typically designed to "ensure that extending service to new customers benefits existing customers through spreading fixed costs among a larger customer base."<sup>4</sup> See Appendix A to this notice for a list of Minnesota rate regulated gas utilities' gas line extension policies.

Line extension policies have a history of being examined regularly in front of the Commission. In every rate case since March of 1995, the Commission has ordered utilities to address the following questions:<sup>5</sup>

- 1) Should the 'free' footage or service extension allowance include the majority of all new extensions with only the extremely long extensions requiring a contribution in aid of construction ("CIAC"),
- 2) How should the local distribution company ("LDC") determine the economic feasibility of service extension projects and whether the excess footage charges are collected,
- 3) Should the LDC's service extension policy be tariffed in number of feet without consideration to varying construction costs among projects or should the allowance be tariffed as a total dollar amount per customer,

- 4) Is the LDC's extension charge refund policy appropriate,
- 5) Should customers be allowed to run their own service line from the street to the house (or use an independent contractor) if it would be less expensive than having the utility construct the line, and
- 6) Should the LDC be required to offer its customers financing for service extension charges; this could be offered as an alternative to paying extension charges in advance of construction.

In several recent rate cases, utility responses to these reporting requirements have sparked interest in a broader conversation about potential modifications to gas utility line extension policies. In CenterPoint's 21-435 rate case, in response to party comments that CenterPoint should consider modification to its free footage allowance policy for gas line extensions,<sup>6</sup> the Commission agreed that the Future of Gas Docket provided "an appropriate forum for evaluating parties' request to pursue these matters on an industry-wide basis."<sup>7</sup> Similarly, in Xcel Energy's 21-678 rate case, the Commission ordered Xcel to reduce its free footage allowance, while stating that this decision:

*...reflects no judgment on the merits of reducing free footage allowances generally and shall have no effect on the further exploration of line-extension policies in the Future of Gas Docket. The Commission reiterates its language from the CenterPoint rate case that the Future of Gas Docket "provides an appropriate forum for evaluating the parties' request to pursue these matters on an industry-wide basis."<sup>8</sup>*

The Commission also ordered in that 21-678 rate case that Xcel was no longer required to comply with the above-mentioned reporting requirements,<sup>9</sup> in response to witness testimony that stated that this would be best discussed in the Future of Gas docket.<sup>10</sup> Parties also advocated for this topic to be discussed in this docket during the gas Integrated Resource Planning proceeding.<sup>11</sup> Finally, the Commission ordered MERC in its recent 22-504 rate case to conduct a study on its line extension policies in order to inform this conversation,<sup>12</sup> and that report has since been filed in

that docket.<sup>13</sup> The Commission now seeks stakeholder input on this topic in order to inform future decisions on gas line extension policies.
