Therefore, pursuant to the Supplemental Information filed in these proceedings, Midwest Cable hereby notifies the Commission that it withdraws its petition, application, and Settlement Agreement, and relinquishes its conditional Certificate of Authority to Offer Facilities-Based and Resold Local, Long Distance, and Local Niche Services. Because Midwest Cable has not begun to provide service, this relinquishment will have no effect on any customers.
