Attached for the Minnesota Public Utilities Commission's (Commission) review and approval is CenterPoint Energy Resources Corp, d/b/a/ CenterPoint Energy, Minnesota Gas (CenterPoint Energy, CNP, or the Company) Revenue Decoupling (RD Rider) evaluation report for the 2018-2019 year. The Commission authorized the RD Rider in the Company's 2013 rate case in Docket No. G-008/GR-13-316, and authorized modifications in the 2017 Rate Case in Docket No. G-008/GR-17-285.

The Company files its report in the previously authorized format.
