REPLY COMMENTS

INTRODUCTION

Northern States Power Company, doing business as Xcel Energy, submits the enclosed Reply Comments in response to the August 12, 2025, Notice of Extended Comment Period of the Minnesota Public Utilities Commission in the above-referenced docket.

We appreciate the thoughtful Comments from parties and are thankful for their engagement with Peak Time Rebates (PTR). Based on these Comments, the Company is altering its original proposal with the following updates: modifying the estimated energy savings value from 0.32 kW to 0.19 kW per event, updating the first-year participation target from 15,500 to 40,000, and adjusting the budget to reflect the anticipated changes in these savings and participation factors.

In the remainder of these Reply Comments, we address these updates and topics raised by parties in their September 5, 2025, Comments. The topics we discuss in this Reply are as follows:

- Program Design Recommendations
- Cost Effectiveness
- Tracking, Reporting and Evaluation
- Regulatory Pathway & Cost Recovery Mechanism

REPLY COMMENTS

I. PROGRAM DESIGN RECOMMENDATIONS

A. Initiate a Pilot Program

The Minnesota Department of Commerce (Department) and the Office of the Attorney General – Residential Utilities Division (OAG) recommended a limited-term pilot to collect data that will inform the design of a future program. As part of this effort, the Department suggests testing both opt-in and opt-out enrollment strategies, while maintaining the current Energy Action Days (EAD) program, to better understand customer participation and load reductions associated with each approach. They reference the Portland General Electric (PGE) pilot which involved twelve demand response treatments, including opt-in and opt-out approaches.¹

The Company does not believe it is necessary to implement the PTR program on a pilot basis. Launching the program as proposed by the Company, versus a limited pilot, still allows for a focused assessment of outcomes and the collection of meaningful insights to inform future program development, without the high costs of a pilot. This approach leverages the Company's and the industry's experience with similar programs, avoids additional pilot costs, and benefits from the flexible Energy Conservation and Optimization (ECO) framework that will allow the Company to adjust the program as it learns.

The Company's proposed program design already draws from its own experience in developing the EAD program, as well as the experience of other utilities with PTR programs, further counseling against a pilot approach here. For example, in its Comments, the Department proposes a pilot to compare opt-in and opt-out approaches to "test customer acceptance and load reductions under both opt-in and opt-out enrollment approaches."² However, the Company has already tested load reductions in an opt-out scenario through EAD. These results may not have been impacted by an incentive (as offered in PTR) but would have been similar given the size of the savings opportunity per customer. Rather than conduct similar analysis (and therefore spend additional dollars to test these results again and additional dollars to expand the proposed program to include opt-in and opt-out options), we propose to use the insights gained from other utilities, including the PGE study, to narrowly tailor an opt-in program. PGE's decision to adopt an opt-in model aligns with our proposed approach and reflects the most common practice among utilities. As noted

in the OAG comments, “Xcel’s proposed peak time rebate is broadly consistent with that of other utilities surveyed, and Xcel’s proposal generally appears reasonable.”³

Finally, within the ECO framework, the Company has the flexibility to continuously review and adjust programs to ensure they remain effective and responsive to customer needs.⁴ We concur with both the Department and the OAG that there is inherent uncertainty in our assumptions regarding cost-effectiveness and opt-in rates. As originally proposed, the Company has already taken steps to limit the program’s initial scope to test these assumptions and make iterative improvements over time as participation grows. So, although our program would not be a pilot, that program evolution—through growth and refinement—is a standard and expected part of the initiative.

Given the above considerations, the Company does not believe that launching the PTR program as a pilot is necessary.

B. Maintain EAD After PTR Launch

The Department has recommended keeping the EAD program active while testing the PTR scenarios. Given that, apart from the rebate, the programs are nearly identical, the Company has concerns regarding the potential for customer confusion if both EAD and PTR programs were to operate concurrently. To ensure a clear and positive customer experience, and the highest chance for a successful launch of the PTR program, we intend to sunset the EAD program upon the launch of a PTR program regardless of whether a pilot is implemented.

C. Include Existing Demand Response Participants

All commenters support allowing customers currently enrolled in Demand Response (DR) programs to participate in the PTR program at some point in the future. The Department has stated that “it is reasonable to exclude customers currently enrolled in other demand response programs,”⁵ and we agree with this assessment. The Department also recommends that customers be given the option to switch between programs if they choose. As with all our offerings, customers may select the program that best suits their needs, as both AC Rewards and Saver’s Switch are structured as one-year commitments. We agree that initially excluding DR participants is reasonable, provided customers retain the flexibility to switch programs.

The Company shares this perspective and believes that excluding DR participants at the outset is necessary to reduce the complexity of baseline calculations and ensure accurate measurement of energy savings attributable specifically to the PTR program. We support Fresh Energy and the OAG's request for additional information on what would be required to adjust baselines to account for other DR programs. However, this will require further analysis and is best addressed through a comprehensive evaluation, as discussed later in this Reply. As we gain experience and better understand program impacts, the inclusion of DR participants and net-metered customers in PTR can be revisited, with updated baselines developed accordingly.

D. Increasing the Number of Participants

All parties commented on the Company's proposed six percent response rate of 15,500 customer enrollments in PTR the first year of launch. Our rationale for six percent, as requested by Fresh Energy in their comments, was simply to target a small group of customers. In addition, it is important to note that the Company did not originally propose a cap on participation – ECO programs allow the Company to exceed participation goals, which may differ from a pilot created as part of a tariffed filing. Based on parties' comments, the Company has adapted our original proposal to increase the number of targeted customers to 40,000 customers with no cap on participation.

Fresh Energy proposed a first-year enrollment target of 15 percent of the eligible population, or 37,500 participants. They reference PGE's first year results of 80,000 and the Company's long standing Saver's Switch program, which has 420,000 participants across Xcel Energy's northern service territory. In contrast, while the OAG did not recommend a higher participation rate, they referenced a different PGE study which indicated the Company's proposed six percent response rate is on the high end of what PGE experienced in their pilot, concluding that it may be a challenge for the Company to achieve without implementing different marketing approaches. The Department recommends inclusion of an opt-out model as a component of a pilot to enroll significantly more customers.

We are proud of the strong engagement in our Saver's Switch and AC Rewards programs, which we estimate has a saturation of 60 percent of eligible households. However, it's important to note that Saver's Switch has been available for 35 years, whereas in this proposal we are only considering the first-year enrollment of PTR. Fresh Energy requested that the Company update Attachment A of our Petition to show the eligible number of customers. This is a challenging request based on eligibility criteria on the commercial side, but we provide Table 1 below to focus on

the eligibility of residential customers.

The Company has revisited the initial analysis and agrees with Fresh Energy that a first-year enrollment target of 40,000 participants is achievable with an opt-in program in conjunction with a more robust and targeted marketing strategy than originally proposed.

E. Marketing Approach

As noted above, upon reviewing a PGE study, the OAG recommends that the Company be required to market the program through direct mail including letters and post cards. Additionally, they suggest targeting customers with high peak load and in constrained areas of the grid. They further recommend developing the capability to send potential participants personalized bill messages and providing customers feedback on performance within 24-48 hours of a control event. The Department also supports targeting customers with high peak load in addition to low-income households and communities.⁶

The Company agrees that targeting specific customer segments, such as current participants in EAD, customers with high peak load and low-income households, is an effective strategy to encourage program enrollments. While our current billing system does not support personalized bill messaging, and developing such functionality would be both costly and time intensive, we can actively promote PTR through standard on-bill messages. These messages would direct customers to additional program information and enrollment resources.

While the Company does not recommend extensive use of direct mail due to its relatively high cost, typically exceeding \$0.50 per piece, and modest response rates of

up to 2-5 percent, it may be appropriate in limited quantities. Specifically, direct mail could be used to reach targeted customer segments for whom we do not currently have email addresses. Depending on the response rates from initial mailings, the Company may consider expanding this approach.

To achieve a first-year enrollment target of 40,000 customers, the Company recognizes the need to broaden its marketing strategy beyond email, on-bill messaging, limited direct mail and our website. Additional outreach methods may include targeted digital advertising, social media campaigns, and other innovative engagement channels.

The Company will also explore opportunities to leverage the My Energy Portal and Home Energy Reports to encourage participation in the PTR program. This will be reviewed further as we transition to the new program implementer for this offering.

II. COST EFFECTIVENESS

A. Energy Savings

Peak Time Rebates will offer participants an opportunity to earn incentives by providing bulk system grid services through behavioral changes at their home. While there are existing programs that incentivize activity through action for several of the major loads within the home (i.e. AC Rewards, Saver's Switch,), there are other devices that could provide load reduction through a technology agnostic option such as PTR. Customers could act by reducing usage of regular, everyday items such as shutting off lighting, adjusting heat pumps and other non-central cooling systems, not charging electric vehicles, and reducing the use of other appliances. These are potentially normal activities that could result in load reduction and incentive payments to customers for reducing their activity compared to their baseline usage. In a typical home, the largest load reduction opportunity is often the control of cooling equipment. In the absence of this reduction opportunity, either through participation in another load control program or lack of equipment or controls, the remaining options typically result in lower or less consistent reduction which may impact the performance assessment of the program.

Our original savings estimates were based on assumptions that were found later to be inaccurate. Therefore, we concur with both the Department and OAG that the originally proposed 0.63 kW savings was overstated. In our Comments⁷, we provided

energy savings values for several utility programs and based on this analysis, we proposed a revised savings of 0.32 kW – assuming that by removing demand response participants, we would find savings higher than the average of 0.21 kW (see Table 1).

In their Comments, the Department and OAG referenced energy savings data from utilities including PGE & ComEd. For these utilities, different source documents were used to derive the savings estimates in comparison to our analysis. In response, the Company conducted an additional review of multiple source documents for utility programs beyond what had been conducted in March of 2025 and included as Attachment B to our Petition.⁸

As noted in our September Comments, the wide variation in reported savings across utility programs can be attributed to several factors including: limited or no control events, customer participation in multiple demand response programs, seasonal timing of events, the year in which the study was conducted, weather variability, baseline methodologies, and difference in energy costs. Given these variables, it is challenging to predict the specific energy savings our program would yield. We believe that the PTR program will yield savings between 0.19 kW and 0.32 kW, which as an opt-in option, is higher than the opt-out savings per customer of the EAD program of 0.02 kW. However, without additional experience in the program, these savings will be unknown.

For the purposes of our cost benefit analysis, we have updated our proposed energy savings from 0.32 to 0.19. kW, which is the average energy savings of the programs listed below and approximately the same savings Connexus has seen with their PTR program in the last few years. Of note, as part of the ECO portfolio, the Company will propose to claim actual savings from the program rather than using an estimate.

B. Budget

The Company’s proposed budget has been updated to reflect the higher enrollment target. To support this expanded goal, a more robust marketing budget will be necessary. While the estimated savings per customer has decreased, overall rebate expenditures are expected to rise due to the increased number of participants. Accordingly, both rebate and marketing allocations have been adjusted upward for our proposed opt-in program.

C. Updated Cost Benefit Analysis

An updated cost benefit analysis for the PTR program, with a revised participation level and corresponding budget updates is included as Attachment A. This analysis was conducted using the methodology applied to ECO program evaluations, as defined by the Department.¹¹ The following assumptions were used to assess cost-effectiveness.

The results show that the program does pass the cost effectiveness requirement with a Benefit/Cost Ratio of 1.18 using the Minnesota Test, provided the assumptions regarding budget, participation and savings are accurate.

D. Capacity Reductions and MISO Registrations

In their comments, the Department and Fresh Energy asked for more information on the Company's plans to use PTR to lower our peak demand forecast and capacity obligations.

As discussed in the Petition, the Company intends to call events based on anticipated system demand and include the program as a demand response resource in the Integrated Resource Plan (IRP). Specifically, in the last IRP, our demand response programs were included in our modeling analysis as supply-side bundles available to meet our load serving needs. The Company included four "bundles" of demand response which included a variety of resources including MISO registered resources as well as other demand response. Bundle 2 specifically included the anticipated impacts of EAD. The capacity from the selected demand response bundles offsets the need for other resources that might have been selected by the model. By including the impacts of DR, the Company is affecting the need to build new capacity resources and as such is realizing the benefits of a behavioral DR program for our customers.

However, in the near-term, the PTR program will not be registered in MISO. Utility Peak Time Rebate programs are relatively new, with several programs launched in just the last few years. There is not sufficient information on any of the programs to determine with confidence what the forecasted savings will be, as referenced above, in the widely varied average energy savings per program. Without reliability, there is a significant risk of being penalized.

The Department referenced the ComEd and BGE programs, both of which are funded by PJM. While this may be an appropriate resource for PJM, PJM operates in deregulated markets and requires participation in a mandatory capacity auction making it significantly different from MISO and thus the two are not reasonably compared.

And, while the OAG's suggestion to consider PTR as a non-wires alternative in constrained areas is an admirable goal, it is not realistic in the short term. However, the PTR event strategy will continue to be evaluated for most effective grid relief impacts to balance out the financial commitment.

III. TRACKING, REPORTING AND EVALUATION

As previously discussed, the Company intends to file the PTR program with the Department as part of our ECO Portfolio. In this scenario, the Company plans to include PTR program results such as participation, energy savings and program expenditures, as part of the annual ECO Status Report filed each year on April 1.

A formal program evaluation is recommended once the program has launched and sufficient enrollment and operational experience have been gained to support meaningful analysis. This is typically after two years from launch. This evaluation will gather data to inform several of the metrics suggested by the Department and OAG. It will provide a deeper understanding of energy savings, assess program delivery and customer satisfaction, examine market dynamics and evaluate cost-effectiveness. The insights gained will help the Company refine the program design and implementation to better meet customer needs and regulatory objectives.

As part of the evaluation, which will require a third-party evaluator, we can commit to including the following additional analysis for which we are able to track.

- a. Number of customers (1) invited to opt-in and (2) opting in
- b. For each control event
 - a. Date and timeframe
 - b. Hours' notice given
 - c. Xcel's distribution-system peak in MW during the event timeframe
 - d. Average load reduction per customer
 - e. Number of participants sent follow-up emails and timeframe
- c. Potential savings per year in kW and kWh
 - a. Total
 - b. Per control event
 - c. Per customer

- d. Actual savings per year in kW and kWh
 - a. Total
 - b. Per control event
 - c. Per customer
- e. Updated Cost-Benefit Analysis

As part of the ECO portfolio, if approved by the Department, we would include this evaluation as part of our Status Report but also include a copy of the evaluation as part of this docket.

IV. REGULATORY PATHWAY & COST RECOVERY MECHANISM

The Company appreciated the recommendations of the Department and OAG that, following Commission input to help shape the program, formally incorporating it into the Company's ECO portfolio—via a formal modification or through our next Triennial of which will be filed June 1, 2026—is a logical and appropriate path forward. This approach offers a clear framework for cost recovery while ensuring alignment with broader regulatory and policy objectives.

CONCLUSION

The Company appreciates the opportunity to provide further details and clarification on our proposed PTR program. Based on the comments received, the following updates were made to our proposal: the estimated energy savings value changed from 0.32 kW to 0.21 kW per event, the first-year participation target has been updated from 15,500 to 40,000, and the budget has been modified to reflect the anticipated change in savings and participation. We look forward to additional stakeholder engagement.
