Otter Tail Power Company (Otter Tail Power) hereby submits to the Minnesota Public Utilities Commission (Commission) its Compliance Filing in the above-referenced matter. The Commission's Docket No. E-999/CI-23-151, April 12, 2024, Order Further Clarifying Implementation of Changes to Minn. Stat. § 216B.1691, Ordering Point 1 seeks that electric utilities file a list of electric utilities on whose behalf they intend to report on annually in the applicable REC retirement docket.

Otter Tail Power provides wholesale electricity to three towns covered by the change in definition following the passage of H.F. 7: Newfolden, Nielsville, and Shelly. Otter Tail Power has historically included sales to these towns in annual Renewable Energy Standard (RES) compliance filings as part of its total sales. In future compliance filings, Otter Tail Power will continue to report RES compliance on behalf of these municipalities but will distinguish renewable energy credits (RECs) retired on their behalf in the filing. The Company will include 100 percent of the obligation of each of these towns in the report. The table below lists the 2024 RES compliance obligation for each town.
