In the Matter of the Application of Enbridge Solar (Plummer), LLC for a Site Permit for the up to 130 MW Plummer Solar Project in Red Lake County, MN

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold public hearings on the application of Enbridge Solar (Plummer), LLC (Plummer Solar) for a site permit for the up to 130 megawatt alternating current photovoltaic solar energy generating system and associated facilities in Red Lake County, Minnesota.

Plummer Solar is proposing to construct an up to 130 MW solar energy generating system located in Emardville Township in Red Lake County, Minnesota. The proposed project would be located on 855 acres, and will use photovoltaic solar panels mounted on single axis tracking systems. Underground collection cables will gather and send the electric power generate by the solar panels to a project substation. The project will interconnect to an existing 115 kilovolt (kV) transmission line immediately adjacent to the project site via a short (<1,500 ft) above ground 115 kV transmission line. Plummer Solar filed a Generator Interconnection Agreement application with Midcontinent Independent System Operator (MISO) in 2022, and expects to sign an agreement in January 2025.


