In a filing on May 5, 2025, Xcel Energy requested to expand the route width for portions of Segment 2 North and Segment 2 South near the North Rochester Substation. ² This request was made to allow the Project’s 345 kV line to be constructed adjacent to the existing Hampton – North Rochester 345 kV line rather than double-circuited with this line. This change is needed because one of the transmission projects that was approved by MISO as part of its L RTP Tranche 2.1 projects involves adding a second circuit to the existing Hampton – North Rochester 345 kV line such that the Project’s 345 kV line cannot be double-circuited with this line as proposed in the Application.
