2025 GAS UTILITY INFRASTRUCTURE COST RIDER

DOCKET NO. G002/M-24-369

Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission (Commission) this Reply to the January 2, 2025 Comments of the Department of Commerce, Division of Energy Resources (Department) regarding our 2025 Gas Utility Infrastructure Cost (GUIC) Rider Petition filed October 31, 2024 in the above-noted docket.

We appreciate the Department's review of our 2025 GUIC Rider Petition and their recommendation that the Commission approve our proposal. We agree with the Department's recommendation that we provide a compliance filing in the present docket, based on Commission decisions, within 10 days of Commission Order, including electronic files with formulae intact of the revenue requirement and corresponding rate factor schedules. We also commit to submitting a compliance filing upon the implementation of final rates in Docket No. G002/GR-23-413¹ detailing the impacts on the Company's GUIC Rider for GUIC projects rolled into base rates and updating the revenue apportionment allocators, prior to implementation of the 2025 GUIC Rider factors on March 1, 2026.

The Department noted that in previous years the Company provided the bill impact for three factors, but in this docket the Company only provided the impact of the current factors (2023) and the impact of the proposed factors (2025). They also noted that they were unable to verify the Company's impact of the current factors. In our Petition, we had inadvertently calculated the current year impacts using a blended

GUIC factor average from 2022 and 2023 instead of the 2023 GUIC factor. We apologize for any confusion caused. Please see the table below for a revised version of Petition Table 11, including the impact for the factors for 2023, 2024, and 2025. Our calculations are consistent with the Department's estimated bill impacts in Table 9 of their January 2, 2025 Comments.
