DECISION ITEMS

1. ** PL9/CN-14-916; Enbridge Energy, Limited Partnership PL9/PPL-15-137

In the Matter of the Application of Enbridge Energy, Limited Partnership for a Certificate of Need for the Proposed Line 3 Replacement Project in Minnesota from the North Dakota Border to the Wisconsin Border; In the Matter of the Application of Enbridge Energy, Limited Partnership for a Route Permit for the Proposed Line 3 Replacement Project in Minnesota from the North Dakota Border to the Wisconsin Border.

 Whether the data identified in the Administrative Law Judge's September 22, 2017 Order Certifying Data Determination and Staying Release of Data is public under the Minnesota Government Data Practices Act. (PUC: Ek)

Found that data in question is public and required the parties to refile the applicable report and other redacted documents within 10 days after the Commission issues a notice designating the data as public.

- Should the Commission allow Xcel to accept the current Subscriber Agency Agreement and Consent Form (SAA) for an additional 24 months? (PUC: O'Grady)

Tariff change approved.

3. * P415/AM-17-65 Melrose Telephone Company

In the Matter of a Request to Compel Melrose Telephone Company to Reissue Customer Notice.

Should the Commission require Melrose to reissue a notice of rate increase? (PUC: **O'Grady**)

Took no action and closed the docket.

4. * E017/M-17-279 Otter Tail Power Company

In the Matter of Otter Tail Power Company's Petition For Approval of Merricourt Wind Project.

- Should the Commission approve Otter Tail's investment in the Merricourt Project?
- Should the Commission Determine that the proposed Merricourt Project qualifies as an eligible energy technology that can count towards the Minnesota Renewable Energy Statute (RES) requirements set forth in Minn. Stat. §216B.1691?
- 3. Should the Commission authorize future cost recovery for the Merricourt Project through Otter Tail's Renewable Rider, subject to Commission review and approval of specific costs to be presented by Otter Tail in a future petition under Minn. Stat.§216B.1645, subd. 2a.?
- Should the Commission Grant OTP's requested variance to the filing requirements of Minn. Rules 7825.1800(B) and Minn. Rules 7825.1400 items (A)-(J)?
- 5. Does the proposed Merricourt Project require a certificate of need pursuant to Minn. Stat. §216B.243?
- Should the Commission Require periodic informational reports on the Merricourt project's Bird and Bat Conservation Strategy minimization and mitigation activity undertaken as outlined by the DOC? (PUC: Fournier)

Project approved; rider recovery approved with limitations.

5. ** G6960/M-16-214 United Natural Gas, LLC

In the Matter of a Petition by United Natural Gas LLC (UNG) for approval of its Request for a Small Gas Utility Franchise Exemption.

Does the Lower Sioux's status as a sovereign nation mean that UNG's provision of natural gas service to the Lower Sioux is not subject to Commission jurisdiction and regulation?

Should the Commission approve UNG's request to extend its current

Lafayette/Courtland, MN small gas utility franchise exemption from Commission regulation, to include incidental service along the GMT intrastate pipeline route approved in Docket No. 16-1026? (PUC: **Brill, Bonnett**)

Granted the exemption; found that the Lower Sioux Indian Community may regulate the Company's provision of natural gas service to tribal-owned entities; found that the Company is not prohibited from delivering gas service along the GMT pipeline; approved rate book changes; required further filings.
