2. Should the Commission approve Xcel's request to delay any increase to the Nuclear Decommissioning Trust accrual until January 1, 2022. Or, alternatively, approve a deferral so the Company can fund the increased accrual in 2021?
3. Should Xcel's proposal be considered a continuation of its 2015 Multi-Year Rate Plan (MYRP) and, if so, would Commission approval of the proposed 2021 true-up mechanisms conflict with the five-year limit on MYRPs in the MYRP statute? (PUC: **Alonso, Larson, Ubani**)
