#### **Comments of the Energy CENTS Coalition**

The Energy CENTS Coalition (ECC) appreciates the opportunity to provide comments regarding Xcel Energy's ("Xcel" or "the Company") "stay out" proposal as an alternative to a contested rate case proceeding filed in Docket No. G002/GR-21-678. Previously, ECC has supported similar proposals brought forward by the company, most recently in the electric rate case stay-out approved by the Commission in 2020.<sup>1</sup> Considering the persistent economic effects of the ongoing COVID-19 pandemic and the highly variable levels of financial recovery that consumers have been able to achieve in the past year, ECC believes that maintaining base rates at 2010 approved test year levels would provide relief for ratepayers. Protecting ratepayers from increased natural gas prices is particularly important given the projected increase in the commodity cost of gas and rising prices for food and other essential items.

ECC supports the present stay out proposal brought forward by Xcel Energy, primarily because \$31.6 million in projected incremental depreciation, distribution O&M, and property tax expenses for the year 2022 is deferred. Furthermore, the present stay out proposal will provide stakeholders with the opportunity to closely examine the actual expenditures (incremental depreciation, distribution O&M, and property tax expenses for the year 2022) incurred by Xcel in the next rate case. Residential ratepayers, particularly lower-income ratepayers, are experiencing economic hardship caused by the pandemic and

most Xcel Energy residential customers are currently paying for the costs of the February 2021 natural gas price spike. In addition, "nearly half of U.S. households that heat primarily with natural gas will spend 30 percent more than they spent last winter on average -50 percent more if the winter is 10 percent colder-than-average and 22 percent more if the winter is 10 percent warmer-than-average."<sup>2</sup>

Finally, as of September 2021, 13.4 percent of Xcel residential customers are past-due, the highest monthly number reported in 2021. The average past due amount is \$471.<sup>3</sup> Adding an 8.6 percent natural gas rate increase will worsen households' current financial strain.

ECC respectfully requests, therefore, the Commission approve the Company's deferral proposal.
