#### **REPLY COMMENTS**

#### **Reply Comments**

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission (Commission) this Reply pursuant to the Commission's November 3, 2021 NOTICE OF SHORTENED COMMENT PERIOD (Notice) and in response to parties' Comments received November 10, 2021 in the above-noted docket. As the Commission is aware, the Company submitted its Application for Authority to Increase Rates for Natural Gas Service in Minnesota (and the companion Base Cost of Gas application<sup>1</sup>) on November 1, 2021 in Docket Nos. G002/GR-21-678 and G002/M-21-749. In the present docket, we requested approval of a deferral of depreciation expense, distribution O&M expenses, and property tax expenses for calendar year 2022 as an alternative to litigating the rate case proceeding (Stay-Out Proposal). This would allow us to avoid a base rate increase for our natural gas customers and free up resources for state agencies and stakeholders to engage in other important matters of state policy. In the event the Stay-Out Proposal in the present docket is not approved, the Company filed its request for authority to increase rates for natural gas service for 2022.

The Commission's Notice asked parties to comment on whether each deferral component of the Stay-Out Proposal should be approved, and if approved, what reporting requirements should be established. On November 10, 2021, the Minnesota

Department of Commerce, Division of Energy Resources (Department), Minnesota Office of the Attorney General, Residential Utilities Division (OAG), Citizens Utility Board (CUB), Energy CENTS Coalition (ECC), and Suburban Rate Authority (SRA) filed Comments in response to the Notice.

We first note our appreciation for the comments CUB, ECC, and SRA provided in support of the Stay-Out Proposal. In its comments, CUB noted it would be helpful for the Commission to confirm that approval of the proposed deferrals "will confer no presumption of the prudency or recoverability of the Company's deferred expenses." As we stated in our Petition, we acknowledge that "granting a deferral does not guarantee cost recovery, but instead gives the Company the opportunity to demonstrate in a future general rate case that the expenses were actually incurred and prudently benefited customers." We also note that, as in all rate proceedings, under Minn. Stat. § 216B.16, subd. 4, we would bear the burden of proving the rate change in our next rate case—including such expenses—is just and reasonable.

We also note that the Department raised some concerns with the Stay-Out Proposal, and the OAG stated it needed more time and information before it could substantively weigh in on the Proposal. We appreciate these positions and have reached out to both the Department and OAG to discuss the Proposal and provide them any additional information they may need. We are committed to working with these agencies, and we will supplement these Comments if, after meeting with parties, we believe it would be helpful to clarify our positions.

We continue to believe avoiding a general rate case is in the best interest of our customers and interested stakeholders and that the Stay-Out Proposal is an appropriate path forward to do so. That said, should the Commission not approve it, we are prepared to move forward with the general rate case filed on November 1.

## CONCLUSION

We respectfully request that the Commission approve the Stay-Out Proposal, including deferral of depreciation expense, distribution O&M expenses, and property tax expenses for 2022 so that we may withdraw our pending natural gas rate case.
