

Greenbacker Renewable Energy Corporation (Greenbacker) contracted Westwood Professional Services, Inc. (Westwood), to conduct a Phase Ia Cultural Resources Literature Review for the Community Wind South Project (Project) in Nobles County, Minnesota (Exhibit 1). The current Project intends to retrofit 15 existing turbines with longer blades and different nacelles, as well as the installation of new transformers at the base of each turbine. Application to the Department of Commerce and the Minnesota Public Utilities Commission will be required for the Project.

The literature review examined documentary resources including historic maps, archaeological site files, historic structure inventories, and previous cultural resource survey reports. Rigden Glaab, M.A., RPA, meets the Secretary of Interior's Professional Qualification Standards for archaeology as stipulated in 36 CFR Part 61 and served as Principal Investigator for the Project. The literature review study area included the Project area and a one-mile "buffer" zone (Table 1, Exhibit 1).

On March 26, 2020, Westwood Architectural Historian Sara Nelson, reviewed files at the State Historic Preservation Office (SHPO) at the Department of Administration in St. Paul, MN. The review examined historic/architectural structure inventory files, archaeological site files, and the National Register of Historic Places (NRHP) database, to obtain a list of previously recorded archaeological (historic and prehistoric) and historic/architectural resources within the Project area and a one-mile "buffer" zone. Cultural Resources Manager Ryan P. Grohnke reviewed files on the online Portal maintained by the Office of the State Archaeologist (OSA).

Other documentary research sources used included county and township histories, historic contexts, environmental background, historic maps and atlases, historic J.W. Trygg Maps (1969) developed

from original township land survey records, *An Illustrated Historical Atlas of the State of Minnesota* (Andreas 1874), and the *Standard Alas of Nobles County* (Ogle & Co. 1914).

### Previous Cultural Resources Investigations

A review of survey reports at SHPO revealed that three previous Cultural Resources surveys have been conducted for earlier wind farm projects in the vicinity of this Project. In 2009, the "Cultural Resources Literature Review," "Phase I Archaeological Survey," and "Phase I Archaeological Survey Addendum I" were completed for the Nobles County Wind Farm (operating adjacent to the Project) by The 106 Group Ltd. The report identified eight archaeological sites; two are located in the one-mile buffer (21NO0064 and 21NO0069), and none are located within the Project area. All eight sites were recommended not eligible for listing in the NRHP and no further archaeological work was recommended prior to construction. The "Archaeological Survey for the Proposed Community Wind South LWECS Project" was completed in 2012 by Blondo Consulting, LLC. The survey included "an attempt to relocate archaeological sites 21NO0028 "The Indian Hill Site II" and 21NO0029 "The Indian Hill Site I," which are located within the Project area, but "no evidence of either site was found." The survey identified archaeological Summit Lake Site (21NO0071) within the Project area, which was recommended not eligible for listing in the NRHP. The report did not recommend further archaeological work prior to construction.

An "Architectural Survey for the Proposed Community Wind South LWECS Project" was completed in 2012 by Blondo Consulting, LLC. Of the 77 resources identified, ten are located within the Project area and 36 are located within one mile of the Project. Nearly all resources were recommended not eligible for listing in the NRHP. Of the three resources recommended potentially eligible, one is located within the Project area (NO-SLT-038). SHPO has not issued concurrence of eligibility for any of the properties.

#### Archaeological Sites

Three previously recorded archaeological sites are located within the Project area (Table 2, Exhibit 1). The 2012 survey identified Summit Lake (21NO0071), consisting of a small lithic scatter site. The survey could not relocate the previously identified Indian Hill Site II (21NO0028) or Indian Hill Site I (21NO0029). None of these sites were recommended eligible for the NRHP.

There are four sites located within one mile of the Project area. The Elsing Site (21NO0030) was identified in 1979; the 2009 report noted that "the site's NRHP eligibility was not determined [in 1979]; however the commentary on the site form states that the site should be tested." The 2009 survey identified two sites, 21NO0064 and 21NO0069, which both consisted of a single chert flake and were recommended not eligible for the NRHP because of their poor contextual integrity. Site 21NOj is an alpha site, which is a site lead from historical documentation or an informant report that has not been verified by a professional archaeologist. Site 21NOj is listed as a mounds site; the SHPO database and inventory form did not provide further details and the site has not been evaluated for NRHP eligibility.

## Historic/Architectural Resources

Forty-six historic/architectural resources have been previously inventoried within one mile of the Project area, ten of which are located within the Project boundaries (Table 3; Exhibit 1).

#### Other Sources

Other archival resources investigated included the historic J.W. Trygg Maps (1969) based on the original government land survey of the townships, *An Illustrated Historical Atlas of the State of Minnesota* (Andreas 1874), and the *Standard Alas of Nobles County* (Ogle & Co. 1914). Neither the Trygg Maps nor the Andreas Atlas showed any potential cultural resources. In the 1914 Ogle Atlas, State Highway 266 is indicated running northwest out of Reading, and generally parallel to the Chicago & Rock Island railroad corridor. In addition to homesteads throughout the area, four schools and one church were indicated within the Project buffer. There were no other potential cultural resources.

#### Recommendation

Because this Project constitutes a re-power consisting of retrofitting existing turbines, which will most likely use existing infrastructure, no new ground disturbance is anticipated. In that event, no further cultural resource investigations are recommended. Westwood recommends a Phase I Archaeological Survey for previously undisturbed locations that may be physically impacted by

construction of the proposed Project. New work at existing turbines and utilization of existing roads or previously utilized crane walks will not necessitate archaeological survey.

None of the historic architectural resources within and around the Project area are eligible or listed in the NRHP. The activities proposed as a part of this Project will have no effect on historic properties. Westwood does not recommend further review of historic architectural resources.

If the Project is federalized, the scope of required cultural resource investigations would be determined by the functioning Federal lead agency in cooperation with the State Historic Preservation Office (SHPO) and pertinent Tribal Historic Preservation Offices (THPO) as defined in both Section 101 of the National Environmental Policy Act of 1969 (NEPA) and Section 106 of the National Historic Preservation Act of 1966 (as amended) (NHPA).
