In the Matter of the Application of Louise Solar Project, LLC for a Certificate of Need for the 50 MW Louise Solar Project in Mower County, Minnesota MPUC Docket No. IP-7039/CN-20-646

Dear Mr. Seuffert:

Louise Solar Project, LLC ("Louise Solar" or the "Applicant") submits these reply comments regarding the completeness of its application for a Certificate of Need ("CN Application") for a 50-megawatt ("MW") alternating current solar large energy facility in Mower County, Minnesota ("Project"). Louise Solar appreciates the Department of Commerce, Division of Energy Resources' ("DOC-DER") thorough review of the CN Application and comments on the permitting process going forward. Louise Solar provides these reply comments to address the few issues discussed in the comments of DOC-DER, as well as to discuss the process for further review of the CN Application.

In addition, on or before March 8, 2021, comments were filed by LIUNA of Minnesota & North Dakota and one member of the public. Louise Solar has reviewed these comments and concluded none raised issues with the completeness of the CN Application. Louise Solar anticipates that the issues raised in these public comments will be addressed during the permitting process.

Completeness.

DOC-DER generally "concludes that Louise [Solar] met the completion requirements" but also recommends Louise Solar provide information to "address options as of a different size (larger and smaller)." The CN Application discusses the factors that weigh in favor of the 50 MW project, including the general need for renewable energy generation, the available transmission resource opportunities at the site location, commercial viability, and cost-effectiveness and economies of

size for the project. *See, e.g.*, CN Application at Sections 4.2.1, 5.1.1, and 5.2. Additionally, Louise Solar provides this requested discussion:

A solar project of smaller or larger size may be competitive within the marketplace, but Louise Solar believes the proposed Project size provides a number of advantages. EDFR, Louise Solar's parent company, has generally found that 50 MW is the threshold at which construction costs are competitive for solar projects connecting at transmission level voltages and economies of scale can be realized on the procurement of the project's components. Similarly, for this site, the transmission interconnection costs are very competitive for a 50 MW solar project – the second lowest interconnection costs on a per MW basis of any current solar project in Minnesota with a MISO interconnection. As compared to a smaller solar farm, the Project provides economies of scale which the Applicant believes will reduce per megawatt hour costs of energy and provides efficiencies in transmission capacity utilization.

A larger solar farm, by contrast, may present additional construction cost and equipment procurement economies of scale, but at this site and at many others across the MISO region, interconnection costs are much higher on a per MW basis for a larger solar project due to expected network upgrades.

As it relates to the environmental impacts, a smaller or larger solar farm would be similar on a per solar panel basis but adjusted at scale to the size of the project.

In this rapidly growing solar market, the availability of projects of varying sizes provides cost-effective solar solutions to a wider range of potential customers, as not every potential customer has the capacity to purchase energy from a larger project, while many mid-size customers may find a 50 MW project ideal for their needs.

Application Review Process, Joint Proceedings, and Environmental Review.

Louise Solar agrees with DOC-DER's assessment that a contested case proceeding is not warranted. Louise Solar respectfully requests that the Commission find a joint processing of Louise Solar's CN Application and Site Permit Application ("SP Application") (MPUC Docket No. IP-7039/GS-20-647) (together, "Applications") is justified and that a single environmental review document, an environmental assessment in lieu of an environmental report, be prepared for the Project to provide a more efficient and less confusing public review process. Louise Solar also agrees that it is useful to refer the matter to the Office of Administrative Hearings ("OAH") for a public hearing and preparation of a full administrative law judge report with recommendations.

Consistent with Louise Solar's reply comments filed concurrently in the Site Permit docket (MPUC Docket No. IP-7039/GS-20-647), Attachment A to this letter includes a suggested schedule for completing this joint proceeding within the statutory timeframes and in a manner that

allows Louise Solar to complete construction in 2022. Solar construction is generally staged for a late-year (Q4) commercial operation date based on milestones set in finance and power purchase agreements. Minnesota winters and spring restrictions limit the pace of construction and activities that can take place during nearly half of the year. A late 2021 permitting decision allows equipment and contractor procurement and the finalization of plans in a manner that ensures an end of 2022 in-service date. Delaying a permit decision into 2022 could delay the in-service date by a full year, unnecessarily postponing local economic development, new jobs, and the climate benefits of this project.

Conclusion.

Louise Solar respectfully requests that, with the additional information provided in these reply comments, the Commission accept the CN Application as complete; find there are no contested issues of fact with respect to the proposed facility; set a schedule consistent with Attachment A that allows for the joint processing of Louise Solar's CN Application and SP Application and refer the matters jointly to the OAH for a public hearing and preparation of a full administrative law judge report with recommendations; and find that an advisory task force is not warranted.
