PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold a remote-access public meeting on the applications of Louise Solar Project, LLC (Louise Solar) for their proposed solar facility in Mower County. The purpose of the public meeting is to inform the public about the review process to be used, and the project being proposed, to obtain public input on the proposed project, and to compile the record for the Commission to consider in making a final decision on the permits. Due to the current COVID-19 pandemic, the remote-access public meeting will replace the standard in-person meeting. Similar to an in-person meeting, the remote-access meeting will provide interested persons the opportunity to: (1) provide comments regarding the need for the proposed project; and (2) ask questions and provide comments on potential issues to be considered by the Commission in its decision-making process or included as a condition in the final site permit.

Project Description

Louise Solar Project, LLC (Louise Solar), an affiliate of EDF Renewables, Inc. filed applications with the Minnesota Public Utilities Commission (Commission) for a certificate of need and a site permit for the 50 megawatt (MW) solar energy generating system.

The proposed project area is comprised of approximately 613 acres of agricultural land located in Lodi and Adams Townships in Mower County, of which the final project design is expected to occupy approximately 325 acres. The excess acreage allows for planned buffers and flexibility in overall design. The primary components of the facility would include photovoltaic panels affixed to a linear axis tracking rack system, inverters, step-up transformers, electrical cables and conduits, electrical cabinets, access roads, a 34.5/161- kilovolt (kV) step-up substation with metering and switching gear, security fencing, below-ground or above-ground electrical collection and communication lines, an operation and maintenance facility, parking lot, up to four weather stations, a 161-kV overhead transmission line (under 1,000 feet in length), a supervisory control and data acquisition system, and temporary laydown areas. The project would interconnect at the existing ITC Midwest 161 kV Adams Substation in the project area.

Louise Solar Project, LLC has not secured a Power Purchase Agreement for the project. However, it has secured a Generator Interconnection Agreement with Midcontinent Independent System Operator on February 22, 2019. The Agreement will allow interconnection of the project to the transmission system. Louise Solar indicated that the power produced by this Project is needed to meet the growing Commercial and Industrial demand for additional renewable energy resources, to accommodate the Solar Energy Standard for public utilities set forth in Minnesota Statutes, and to meet other clean energy goals and requirements in Minnesota and neighboring states.

- Are there other ways to meet the stated need for the project, for example, a different size project or a different type of facility? If so, what alternatives to the project should be studied in the EA?
- Are there any items missing or mischaracterized in any of the applications or issues that need further development?

Process Information

The Commission must approve a certificate of need (CN) and a site permit before the project can be constructed. The certificate of need and site permit applications are being processed jointly and will be reviewed using the informal review process (Minn. R. 7829.1200) and alternative review process (Minn. R. 7850.2800 to 7850.3900), respectively. This meeting satisfies the public meeting requirement for both the certificate of need application (Minn. R. 7849.1400) and site permit application (Minn. R. 7850.3500). Relevant Minnesota statute and rules may be viewed at: https://www.revisor.mn.gov.

The Department is tasked with preparing an environmental assessment for the solar site application filed under the alternative permitting process on behalf of the Commission. The required Environmental Report (ER) will be incorporated into the EA for the Project site permit review. The EA will evaluate the human and environmental impacts of the proposed project,

identify measures that could reasonably be implemented to avoid or minimize impacts identified, and will include the analysis of alternatives required under the review processes.

When the EA is complete, a public hearing will be held. The hearing will be presided over by an Administrative Law Judge from the Office of Administrative Hearings. Members of the public will have an opportunity to speak, provide written comments, and ask questions of the applicant and staff. Upon completion of the public hearing process, the Commission will make a final decision on whether to issue a certificate of need and site permit.


