INTRODUCTION

Northern States Power Company, doing business as Xcel Energy, submits this Petition to the Minnesota Public Utilities Commission (Commission) for approval of a customer credit for the twelfth payment from the United States Department of Energy (DOE) for the partial breach of its contract to take spent nuclear fuel.

On October 27, 2021, the twelfth payment was received in the amount of \$16,550,164.31 for the period January 1, 2020 to December 31, 2020, and we request approval to pass on the Minnesota allocation of \$12,118,943 to our Minnesota electric customers. The Company has placed these funds into a separate external interest-bearing account and will include the interest received, minus bank fees, in calculating the estimated amount of the proposed credit to customers. We request approval to include the twelfth payment with the upcoming planned implementation of the customer credit in the proposed combined 2020 property tax and annual incentive compensation (AIP) credit, which is awaiting PUC approval in Docket No. E002/M-19-688 (the "2020 True-Up docket").

Xcel Energy submits this Petition for approval on November 24, 2021. The effective date and method used to credit the settlement payment is to be determined by the Commission.

IV. HISTORY OF THE CASE AND BACKGROUND

A. 2011 Settlement

Under the Nuclear Waste Policy Act, utilities such as Xcel Energy were required to enter into contracts for the disposal of spent nuclear fuel; utilities contributed \$1.0 million for every kilowatt-hour of electricity generated by their nuclear power plants. In exchange, the DOE committed to transport and dispose of the spent nuclear fuel beginning no later than January 31, 1998. However, the DOE has not accepted any spent nuclear fuel to date.

In 1998, the Company filed the first of two lawsuits against the DOE seeking to recover damages associated with storage of spent nuclear fuel at our Prairie Island and Monticello nuclear generating plants. The Company's claims were for partial breach of the Standard Contract for Disposal of Spent Nuclear Fuel for failing to take title to, transport, and dispose of spent nuclear fuel beginning no later than January 31, 1998. The first lawsuit sought damages through 2004; the second sought damages through 2008.

The Company reached a settlement with the U.S. Government on these lawsuits on July 7, 2011. The settlement provided a mechanism for the Company to recover its spent nuclear fuel storage damages through December 31, 2013. On August 5, 2011,

the Company filed a petition for approval of a credit mechanism to return the settlement amounts to customers in Docket E002/M-11-807.

B. Extended Settlement Agreement

The Company and the Government reached an agreement on January 24, 2014, to extend the 2011 settlement agreement for the recovery of spent fuel storage damages for the three-year period of 2014 through 2016. On December 1, 2014, the Company submitted a compliance filing in Docket No. E-002/M-11-807, which notified the Commission of this extension and that any future payment amounts would be based on the submission of damage claims and subsequent negotiations between the parties.

C. Second Extension of Settlement Agreement

On February 23, 2017, the Company and the U.S. Government agreed to extend the settlement another three years to allow for recovery of damages through December 31, 2019 (Payments 9, 10, and 11).

D. Third Extension of Settlement Agreement

On August 24, 2020, the Company and the U.S. Government again agreed to extend the settlement an additional three years to allow for the recovery of damages through December 31, 2022 (Payments 12, 13, 14). The first payment under this third extension was received on October 27, 2021. Attachment A is a copy of the wire transfer confirming the amount received and has been redacted to remove Company-sensitive banking information. Attachment B provides a derivation of the Minnesota jurisdictional portion of \$12,118,943, along with the estimated credit by customer class. This payment was placed into a segregated bank account established specifically and solely for the settlement proceeds similar to the Company's treatment of the previous proceeds under the 2011 settlement agreement and extended settlement. Attachment C provides a summary of the Minnesota jurisdictional portion of all of the DOE payments received to date.

V. PROPOSED CREDIT MECHANISM

A. One-time Bill Credit

Previous DOE customer credits were returned to active Minnesota electric customers in the form of a one-time bill credit based upon the customers' most recent 12 months of usage. To issue the customer credit as soon as possible, we propose including the Minnesota portion of the DOE payment in the proposed combined 2020 property tax/AIP refund, which is awaiting PUC approval in Docket No.

E002/M-19-688 (the "2020 True-Up docket"). In our August 10, 2021 Reply Comments in that docket, we proposed this potential addition pending the timing of the DOE payment. With an early receipt of the DOE payment, combining these refunds allows the Company to process them together and provides us with the opportunity to return two credits to Minnesota electric customers at once.

B. Credit Implementation

In the 2020 True Up Docket, we proposed a combined credit to Minnesota electric customers where the refund amounts for property tax and AIP would first each be allocated to class, with each class's allocation combined to determine a separate credit factor for each class. Likewise, we would first allocate the DOE funds to class. Once the credit amounts have been allocated to each customer class, a credit factor will be calculated for each customer class based on the 2020 actual kWh usage. The appropriate credit factor will then be applied to each 2020 actual kWh usage to determine the actual credit amount for each customer. Please see Attachment D for an update to the schedule we provided in our August 10, 2021 Reply Comments in the True-Up Docket that now includes the DOE payment and estimated average refund per customer class.

The DOE credit amount would include the actual amount of interest earned by the Company minus any bank fees or charges on these funds.

We propose the following bill message be included on customer's bills and will work with the Commission's Consumer Affairs Office to finalize the message:

Your bill this month includes a refund due to lower actual property tax owed by Xcel Energy and lower employee incentive compensation for 2020 and a settlement regarding nuclear fuel storage per the MN Public Utilities Commission. Your refund appears on your bill as "Elec Combined Refund CR".

The combined refund would appear as a single line item on customers' billing statements. Each customers' credit will be based on their 2020 calendar-year kWh usage—those customers that have 2020 energy usage but who are no longer active at the time we implement the refund and who have a balance of \$2 or more will receive a check.

C. Interest

The Company has placed the funds from the twelfth payment in a separate interestbearing account to protect both customers and the Company and to ensure the funds

are accurately accounted for pending the actual bill credit. The interest-bearing sweep account currently earns 0.05% annually and the interest is posted daily. At the time of implementation, the DOE credit amount would include the actual interest earned in the external account, minus any bank fees or charges on these funds, consistent with the previous one-time DOE settlement credits.

D. Compliance Filings

If the Commission approves the Company's proposal to combine the DOE payment with the 2020 True-up refund, we will begin implementation of the one-time bill credit, including a bill message, based on the customers' 2020 usage in the second quarter or early third quarter of 2022. The Company will submit a compliance filing within 30 days after completion of this bill credit, providing a summary of the settlement payment, interest credited, class allocations and the actual average customer credit per customer class as was done with previous DOE payments in the above-mentioned docket.

Also consistent with Docket No. E002/M-15-1089, we propose providing the same compliance filing within 30 days after receipt of each future payment, and to include documentation similar to Attachments A and B of this filing.

VI. FINANCIAL INSTITUTION INQUIRY COMPLIANCE

In compliance with the Commission's May 12, 2021 Order Point 3, the Company solicited written proposals from three financial institutions – [PROTECTED DATA BEGINS... PROTECTED DATA ENDS] – to

evaluate the yield on the DOE nuclear settlement payments and determine whether a higher interest rate was feasible. The Company asked each financial institution to submit a bid which included the following information:

- 1) recommended account type/investment method;
- 2) proposed yield/interest rate;
- 3) frequency of rate changes; and
- 4) related service fees and costs.

Below we summarize the proposals we received:

ENDS] agreed to increase the current yield on the DOE sweep account from .02%

to .05%. In addition, the bank agreed to apply the yield increase to sweeps on all Xcel Energy bank accounts.

Based on our experience and familiarity with the three financial institutions listed above, we believe it is in the best interest of the Company, our customers, and our stakeholders to continue to keep the DOE funds with [PROTECTED DATA ...PROTECTED DATA ENDS for a variety of reasons. BEGINS... First, [PROTECTED DATA BEGINS... ...PROTECTED DATA **ENDS**] yield was competitive; although the yield was slightly lower than that of ...PROTECTED DATA ENDS], it was [PROTECTED DATA BEGINS... not significantly lower. Additionally, [PROTECTED DATA BEGINS... ...PROTECTED DATA ENDS | currently serves as the Company's primary cash management bank. As such, the Company has both operating processes and relationships with [PROTECTED DATA BEGINS... ...PROTECTED DATA ENDS that create many efficiencies for our customers. Because of the breadth and width of the business the Company conducts with [PROTECTED DATA BEGINS... ...PROTECTED DATA **ENDS**], they have assigned a dedicated treasury management officer whom we can contact directly for immediate treasury management assistance. Having a dedicated treasury management officer reduces delays and other inefficiencies that can arise in managing our funds and might otherwise increase our operating costs. Finally, the additional interest the Company will earn on all of its [PROTECTED DATA] ...PROTECTED DATA ENDS] sweep accounts will more than offset the 0.3% pricing differential between the **[PROTECTED DATA**] BEGINS... ...PROTECTED DATA ENDS | bids. For the foregoing reasons, the Company selected [PROTECTED DATA BEGINS...

...PROTECTED DATA ENDS as the institution to hold these funds.

VII. EFFECT OF THE CHANGE UPON XCEL ENERGY REVENUE

There is no effect on the Company's revenues since the settlement payments will be returned to customers with interest.
