Dear Mr. Seuffert:

The Minnesota Large Industrial Group ("MLIG")¹ respectfully submits this letter comment in response to the Minnesota Public Utilities Commission's ("Commission") Notice of Procedural Comment Period issued for the dockets listed above.² The Notice pertains to the joint petition submitted by the Institute for Local Self-Reliance and Vote Solar (collectively, the "Petitioners") requesting a Commission order directing public utilities subject to the Commission's resource planning requirements to acquire modeling licenses for all intervening organizations in resource planning dockets.³ The Petitioners further request that the Commission consider requiring utilities to provide modeling inputs and outputs, assumptions, spreadsheets, and manuals without data requests.⁴ In response to the Petition, the Commission issued the Notice seeking procedural comments on "[w]hat process ... the Commission [should] use to consider the [Petitioners']

¹ MLIG is a continuing *ad hoc* consortium of large industrial end-users of energy in Minnesota, spanning multiple utilities and functioning to represent large industrial interests before regulatory and legislative bodies. MLIG's members are active in the above-referenced dockets, through *ad hoc* consortiums known as the "Xcel Large Industrials" (or "XLI") and "Large Power Intervenor" (or "LPI").

request, given multiple ongoing IRPs? For example, should the request be moved to a separate docket, or discussed in individual resource plan dockets?”⁵ As a threshold matter and as it pertains to the Notice, MLIG defers to the Commission, utilities, and other stakeholders on the appropriate procedural path forward, and MLIG reserves the right to participate in whatever procedural process the Commission chooses to pursue.

Furthermore, it is MLIG’s preliminary understanding that the relief sought by the Petition would apply to all intervening organizations.⁶ Because MLIG supports development of robust administrative records in resource planning proceedings, it is generally supportive of the direction of the Petition at this time. MLIG is grateful to the Petitioners and Commission for bringing forward and considering this important matter and looks forward to participating in subsequent procedural and substantive comment periods related to the Petition.
