Issue: Should the Commission open a rulemaking proceeding to amend the definition of
“hazardous liquid” in Minnesota Rule 7852.0100, subpart 18?

Topic Open for Comment:

- Should the definition of “hazardous liquid” in Minnesota Rule 7852.0100, subpart 18, be amended to include liquified carbon dioxide?

Background

Nationally, there is increasing interest in carbon capture, usage, and storage technologies that may involve the transportation of liquified carbon dioxide through a pipeline system. End uses of carbon vary but may include underground storage and sequestration or other processes intended to reduce harmful carbon dioxide emissions into the atmosphere.

Minnesota Statutes Chapter 216G, grants the Commission authority to issue routing permits for pipelines that have a diameter greater than six inches and transport hazardous liquids. While some other states regulate carbon dioxide pipelines as hazardous liquids, Minnesota Rule 7852.0100, subpart 18, promulgated in 1988 and transferred from the Environmental Quality Board to the Commission in 2007, does not include liquified carbon dioxide in the definition of “hazardous liquid.” Given the increasing interest in carbon capture, usage, and storage, and reporting of potential pipeline developments in Minnesota, it may be appropriate to evaluate whether liquified carbon dioxide should be included in the definition.
