RE: REPLY COMMENTS PETITION FOR APPROVAL OF AN ELECTRIC CONSERVATION IMPROVEMENT PROGRAM ADJUSTMENT FACTOR DOCKET NO. E002/M-22-158

Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission these Reply Comments in the above referenced Docket. In Comments, the Minnesota Department of Commerce, Division of Energy Resources ("Department") required the Company to provide: (1) An updated 2021 tracker corrected for electric/gas CEE One Stop recording error; and (2) Updated 2021 Electric Shared Savings DSM calculations.

These details are provided in Attachment A to these Reply Comments. Based on these changes, the Company recommends approval of our CIP Tracker as filed on April 1, 2022. Based on the Commission's approval, we will then move forward to provide a compliance filing updating the 2022 CIP Tracker with both the appropriate allocations between electric and natural gas, the approved incentive, and to-date actual spending which will appropriately adjust the DSM Riders.

# A. Background

As noted in the Department's June 8, 2022 Comments at page 3:

In its calculations Xcel noted that the Center for Energy and Environment (CEE)'s One Stop Shop Natural Gas measures were incorrectly recorded in the 2021 electric tracker and will be corrected in the 2022 electric tracker. The Company's CEE One Stop recording error occurred in December 2021 when \$71,421 spend, including both customer incentives and administration, for natural gas measures from CEE's One Stop program was added to the Electric CIP Tracker.

# B. 2021 Tracker

The Company provides an updated 2021 CIP Tracker in Attachment A. This is a hypothetical adjustment to the 2021 CIP Tracker to show what would have occurred in absence of the error. Our accounting structure has closed for the 2021 period and therefore an actual adjustment cannot be retroactively adjusted.<sup>1</sup>

# C. Updated 2021 Electric Shared Savings DSM Calculations

Per the Department's request, we have additionally updated our 2021 Electric Shared Savings Calculations as shown in Attachment A. By adjusting the actual expenditures to reflect the removal of \$71,421, the electric incentive has increased by \$7,142 for a total of \$26,888,142. We note a corresponding decrease of \$7,142 in our 2021 Natural Gas Shared Savings Calculation. This incentive will be updated in our 2022 DSM Tracker in our future compliance filing.

# D. Recommendation

The Company recommends approval of:

- our 2021 CIP Tracker account as filed on April 1, 2022;
- the updated incentive of \$26,888,142; and
- 2022/2023 electric CIP Adjustment Factor of \$0.002506 per kWh; subject to an updated compliance filing including a decrease of \$71,421 in July 2022, updated incentive as approved, and to-date spending.

To maintain consistency between our accounting records and the CIP Tracker, we recommend creating an adjustment between electric and natural gas within the 2022 CIP Tracker rather than retroactively addressing in 2021 which will create differing numbers between tracker, our CIP Status Report, and accounting books. The adjustment of \$71,421 from the electric to natural gas will appear as an "other adjustment." Carrying charges will also be adjusted accordingly.

<sup>&</sup>lt;sup>1</sup> The Company has discussed this matter with Department Staff and articulated its preference for approval of the Trackers as filed in order to keep the year-end 2021 Tracker balances in alignment with the Company's accounting records. Staff indicated that they understood the Company's preference and would make a recommendation following review of the information provided in these Reply Comments.

The Company will provide an updated CIP Factor, bill language, and DSM shared savings calculations in our Compliance Filing upon approval of the Commission.

# Northern States Power Company a Minnesota corporation Corrected 2021 Financial Incentive Calculations

Northern States Power Company, doing business as Xcel Energy, Per the Department's request, has updated the 2021 Electric and Natural Gas Shared Savings Calculations.

In accordance with the Minnesota PUC Orders dated January 27, 2010, August 5, 2016 and February 20, 2020 (Docket No. E,G999/CI-08-133), Xcel Energy respectfully submits these financial incentive calculations. In 2021, the Company achieved electric energy savings of 743,837,488 kWh at the generator at a cost of \$109,504,882. As a result, we respectfully request approval of our CIP electric financial incentive in the amount of \$26,888,142.

# **CIP** Electric Financial Incentive Calculation

According to Orders in Docket No. E,G999/CI-08-133, certain expenses and savings are excluded from the incentive calculation, including regulatory assessments, electric utility infrastructure projects, qualifying solar projects, and third party projects not selected for inclusion in the annual incentive compliance filing. As first stated in our January 30, 2013 incentive compliance filing and continued through the 2021-2022 filings, we elected to include the One Stop Shop program administered by the Center for Energy and the Environment (CEE).<sup>1</sup>The indirect impact third party programs— Enerchange, Energy Intelligence, Energy Smart, and Trillion Btu—are not included in the calculation of the incentive. In addition, during the 2013 Legislature, a provision was added to MN Statute 216B.241, subdivision 7, which allows utilities to exclude the net benefits of low-income programs from the calculation of net benefits for the incentive if the net benefits are negative.
