Dear Judge LaFave:

The Minnesota Department of Commerce, Energy Environmental Review and Analysis, has completed its initial review of Big Bend Wind, LLC's supplemental and amended site permit application in the above referenced matter. Based on this review, DOC EERA concludes that "substantial changes have been made in the project [and] substantial new information has arisen significantly affecting the potential environmental effects of the project." Minn. R. 7850.3700, subp. 3 (2019). Accordingly, DOC EERA intends to revise and re-issue its scoping decision to reflect the revised project. *Id.* Among the issues that led DOC EERA to reach this conclusion include:

- The system alternatives identified in the original scoping decision are no longer appropriate, due to the amended turbine layout and details included in the settlement agreement.
- Three primary turbine locations that are within an area that was identified for placement of solar panels as part of the proposed Red Rock Solar Project.
- DOC EERA anticipates that the Red Rock Solar Project will need to be amended due to Big Bend's proposed turbine layout amendment. Alternatively, at a minimum, the Red Rock Solar Project and the three proposed Big Bend turbines within the Red Rock Solar Project Area will need to be independently evaluated.

• The supplemental and amended wind site permit application identifies four alternate turbine locations that could require a waiver of the Commission's wind access buffer and turbine setback requirements. These alternative locations were neither considered in the original scoping process nor subject to public comment.

In addition, DOC EERA believes its decision to revise its scoping decision is broadly consistent with the Minnesota Environmental Policy Act's goal of promoting informed decisionmaking. *See generally No Power Line, Inc. v. Minn. Env't Quality Council*, 262 N.W.2d 312, 327 (Minn. 1977) (MEPA's purpose is "force agencies to . . . be a source of independent expertise whose scientific investigation can uncover the data necessary to make an informed environmental decision."). Preparing an environmental assessment for a project that is neither planned by the applicant nor contemplated in the existing scoping decision is unlikely to achieve MEPA's objectives.

As shown in the attached schedule, DOC EERA intends to complete its environmental review in an expeditious manner to avoid unnecessary delay. DOC EERA believes that the attached dates reflect an aggressive, but feasible completion timeline. DOC EERA, however, has not suggested revisions to the contested case schedule. These dates—although related—are not within the scope of DOC EERA's environmental review. To the extent changes to the contested case schedule are needed, DOC EERA is available to answer questions, but other parties are likely better positioned to make recommendations.

Thank you for your attention to this matter. DOC EERA looks forward to continuing these discussions during the October 8 prehearing conference.
