RE: INFORMATIONAL UPDATE PRAIRIE ISLAND FUEL STORAGE DOCKET NO. E002/CN-08-510

Dear Mr. Seuffert:

For informational purposes, Northern States Power Company d/b/a Xcel Energy (the Company) provides this update on our addition of dry cask storage at the Prairie Island Nuclear Generation Plant (PINGP) consistent with the Commission's December 18, 2009 Order (the Order) in the above-referenced docket.

The Order authorized the Company's expansion of dry cask spent fuel storage at the PINGP Independent Spent Fuel Storage Installation (ISFSI) pursuant to Minn. Stat. §§ 116C.83 and 216B.243, as well as Minn. R. 7855.0010, *et seq.* Specifically, the Commission authorized the Company to increase the storage capacity of the ISFSI by up to 35 casks, from 29 to 64.




Figure 1 – Concrete Pad Design Proposed in 2008 CON Application

As described in the Company's application for the CON, the existing design of the ISFSI includes enough space on its concrete pads to accommodate 48 casks, sufficient to continue operations through 2022. But, to support the additional 16 casks authorized by the Order, as well as any anticipated casks required for eventual decommissioning, the Company proposed to build two more reinforced concrete pads adjoining the existing pads. Each new pad would measure 216 feet long, 18 feet wide and 3 feet thick. Figure 1 below depicts these proposed new pads immediately to the south of the existing pads.




Figure 2 – Current Concrete Pad Design

Since receiving authorization to increase the dry cask spent fuel storage capacity of the ISFSI, the Company has investigated alternate concrete pad arrangements to increase efficiency, improve worker safety, and potentially decrease costs. Based on this review, the Company has decided to switch from the original design proposed with the May 16, 2008 CON application of two single-wide 18 ft. x 216 ft. x 3 ft. thick pads (7,776 sq. ft.) located immediately South and adjacent to the existing storage pads with space for twenty four (24) TN40HT casks (as shown above in Figure 1) to one double-wide 40 ft. x 216 ft. x 3 ft. thick pad (8,640 sq. ft.) located thirty eight (38') feet south of the existing storage pads with space for twenty four (24) TN40HT casks (as shown above in Figure 2).

We are making these changes for a variety of reasons. First, the shape change from two single-wide pads to one double-wide pad optimizes the use of space within the ISFSI, creating greater opportunities for future pad additions. Second, by changing from a 36-foot wide pad to a 40-foot wide pad provides flexibility for potential future storage technologies which may be placed on the pad. Third, moving the pad location from immediately south of the existing pads to 38 feet south of the pads minimizes risks, costs and radiation doses for workers associated with construction work next to loaded pads. Finally, the updated design for the pad leverages the design of the two existing pads.

On October 29, 2020, we received approval for this design from the Nuclear Regulatory Commission. We enclose a copy of the letter notifying the Company of this approval as Attachment A. Based on this approval, we intend to begin construction on the new pad in the next few months.

Dear Mr. Domingos:

By letter dated July 26, 2019, as supplemented April 29, 2020 and June 10, 2020, Northern States Power Company (NSPM) submitted proposed Amendment No. 11 to Special Nuclear Materials License No. 2506 for the Prairie Island Independent Spent Fuel Storage Installation. The application proposed to increase the storage capacity of the Prairie Island Independent Spent Fuel Storage Installation and sought approval for the design of a new storage pad to be built at the existing facility.

The U.S. Nuclear Regulatory Commission (NRC) staff reviewed the NSPM application, as revised and supplemented, and finds reasonable assurance that: (i) the activities authorized by the amended license can be conducted without endangering the health and safety of the public, and (ii) these activities will be conducted in compliance with the applicable regulations. NRC staff further finds the issuance of the amendment will not be inimical to the common defense and security. In connection with the issuance of the license, an environmental assessment and finding of no significant impact was noticed in the *Federal Register* on October 8, 2020 (85 *FR* 63588).

The NRC staff approved the requested license amendment and revised renewed license condition numbers 22, 23 and 24. In addition, editorial changes were made to the license. The attached amended license supersedes Special Nuclear Materials License No. SNM-2506 dated December 9, 2015. Changes made to the attached license pages are indicated by vertical lines in the right margin. The safety evaluation report and the *Federal Register* notice of issuance for the amended license are also attached.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the publicly available records component of the NRC's Agencywide Documents Access and Management System (ADAMS).
