CenterPoint Energy Resources Corp. d/b/a CenterPoint Energy Minnesota Gas ("CenterPoint Energy" or the "Company") and the City of Minneapolis ("Minneapolis") respectfully submit the following errata to the petition to introduce a Tariffed On Bill ("TOB") pilot program.

On September 1, 2021, the Company and Minneapolis proposed the development of a pilot program to encourage homeowners and renters to invest in making their homes more energy efficient. Under the TOB pilot proposal, all customers could elect to pay for certain energy efficiency upgrades via their natural gas bills. Specifically, the Company and Minneapolis requested the Commission approve a three-year pilot program available to residential and multifamily customers throughout the area CenterPoint Energy serves in Minnesota, along with deferred accounting for costs to be incurred to develop and operate the pilot program.

The Company and Minneapolis submit this errata to correct errors included in the September 1 Initial Filing to Introduce a TOB pilot program. CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Minnesota Gas, (“CenterPoint Energy” or the “Company”) and the City of Minneapolis (“Minneapolis”) respectfully submit the following corrections to the petition to introduce a Tariffed on Bill (“TOB”) pilot program.

I. Corrections

The Company and Minneapolis provide the following corrections to the September 1, 2021 Petition to Introduce a Tariffed On-Bill Pilot Program:

1. Page 6: The Company provides a correction to data collection and calculation errors in the following statement:

The Company’s Low-Income Weatherization and Rental Efficiency programs together serve an average ~~650 customers~~ **1,025 participants** a year, with about ~~45-25%~~ **(250 255)** of those participants being renters or rental property owners¹⁰.

2. Page 9: The Company provides a correction to an adding error in Table 2:
